CRIMINAL COMPLAINT

Defendant,

Complainant, Mary M. Kerrigan-Mares, a Deputy District Attorney, being first duly sworn on oath, deposes and says that:

Count 1: ATTEMPT FIRST DEGREE INTENTIONAL HOMICIDE

The above-named defendant Beginning 7/24/2016 and ending 7/25/2016., in the City of De Pere, Brown County, Wisconsin, attempted to cause the death of Kevin Day, with intent to kill that person, contrary to sec. 940.01(1)(a), 939.32 Wis. Stats., a Class B Felony, and upon conviction may be sentenced to a term of imprisonment not to exceed sixty (60) years.

Complainant is a Deputy District Attorney with the Brown County District Attorney's Office and knows of the above offense on information and belief based upon:

PROBABLE CAUSE

The complainant, being duly sworn on oath, swears that she has had the opportunity to review the police reports from Sgt Guth and Officer Mrstik of the De Pere Department, and other documents supporting this complaint, which are the types of reports and documents kept in the ordinary course of business, which complainant believes to be truthful and reliable because they have proven to be truthful and reliable on numerous occasions in the past.

Officer Mrstik's report includes the following:

On July 25, 2016 at approximately 3:19 am I, Officer Nathan Mrstik of the De Pere Police Department was dispatched to Bellin Hospital in the City of Green Bay reference a subject who was dropped off at their hospital reference a stab wound to his neck. Dispatch indicated Green Bay patrol officers were out with the victim at this time and the victim stated the incident transpired within the City of De Pere, Brown County, State of Wisconsin near the Festival Foods on Main Avenue. I started to respond to Bellin Hospital while I was en route dispatch advised me the patient would now be at St. Vincent Hospital as he was being transferred to their trauma unit.

I arrived at the hospital and was met in the parking lot by City of Green Bay officers, Kaitlyn Czarnecki, Daniel Greene along with their Lieutenant Clinton Beguhn. Green Bay officers advised me the victim was identified as KEVIN J DAY M/W (DOB 12-20-1976). They stated DAY did not know where exactly he was in De Pere but it was in brick apartments near the Festival Foods, Mc Donald's and Dunkin Donut's businesses.

Officers further divulged DAY's vehicle was also missing. They informed me it was a 2014 Chevrolet Equinox with Wisconsin Registration of BRWCRW. LT. Beguhn advised Bellin Hospital security has video of the vehicle driving up toward their entrance and dropping the victim off and subsequently driving away. That video footage will be burned onto a compact disc by a Bellin security supervisor and delivered to the police department in the morning. I had dispatch send an attempt to locate on the vehicle reference this altercation. The victim was only able to identify the suspect as a black female weighing around 175 pounds with poofy hair.

Green Bay officers further supplied me with four separate brown paper bags. They stated this was the clothing the victim had on upon his arrival. Located in one bag was a pair of blue jeans and a brown belt, covered with a red substance that resembled the appearance of blood like staining. Located in another brown paper bag was a blue shirt also covered with a red substance that resembled the appearance of blood like staining. The third brown paper bag had in it a pair of white socks that were also covered in a red substance that resembled blood like staining. The final brown paper bag had a green towel within it that was covered with a red substance as well that too resembled blood like staining. I took custody of those brown paper evidence bags and secured them in the trunk of my marked, caged patrol unit within the parking lot of St Vincent Hospital.

A further synopsis was given by Green Bay officers. They advised the victim had a large puncture type stab wound near his throat. The entrance wound was roughly $\frac{3}{4}$ of an inch in diameter. They informed me the victim was being taken for medical testing at this time and was not in his emergency room, room. They informed me the victim advised them he had placed an ad on Craigslist for companionship this weekend and a female answered his ad stating she would be available around midnight, Saturday night. The victim informed Green Bay officers, he went to her apartment located in De Pere. The victim did not know the address only that it was near Festival Foods off of Main Avenue in De Pere. The victim advised he was in the suspect's bedroom and she stabbed him multiple times. They then

got into his vehicle and drove around for roughly three hours before the suspect dropped him off at Bellin Hospital. The victim advised the suspect told him she needed his car because she owed someone money.

I went into the Emergency Room at St Vincent Hospital. I was advised the patient was still in CT and Xray. I spoke with the emergency room doctor who advised me the victim had potential life threatening injuries at this time. He stated he was un sure the extent of the injuries but the subject had a large, puncture stab wound to his neck that went down into his back muscles. The emergency room doctor was not sure until he could further triage the patient after the testing was completed. The emergency room doctor also advised a portion of skin was missing from the victim's neck area.

I went back into the hospital at this time the victim was back in his emergency room, the victim was in trauma room ten. I identified myself to the victim; he verbally identified himself as KEVIN J DAY M/W (DOB 12-20-1976). I asked DAY what happened. DAY stated he had placed an ad on Craigslist looking for female companionship this weekend. He stated a female had responded to his request on Craigslist and they agreed to meet at the female's apartment in the City of De Pere, Brown County, State of Wisconsin. DAY stated he was not sure of the apartment building he went to. He stated he had to call her when he got to the Festival Foods in De Pere and she would direct him from there to her apartment. DAY stated he made contact with the female and she directed him to drive northbound on 10th Street and pass the Mc Donald's and Dunkin Donuts. She further informed him to continue until he arrived at the brick apartment buildings. DAY stated he was told to park in between the four apartment buildings. He parked and the female stated she would be waiting for him on the porch. He stated he got out of his car and a black female with poofy hair was standing on the porch. DAY did not know her name and felt she was roughly 175 pounds. DAY stated the female told him she was 24 years old.

DAY stated they went into her bedroom and he disrobed only leaving his underwear on. DAY stated she was shirtless but the room was dark. DAY stated he laid down on the bed and she went on top of him and they started kissing. DAY stated the female then grabbed something and started stabbing him. He stated she stabbed him right in the neck by his throat. DAY stated there was a lot of blood. DAY further described the object as a knife or something similar. He stated after the female stabbed him in the neck he pushed her off of him and took out the object he had stuck in his neck and threw it on the ground. DAY stated he then started to defend himself and hit the female back but she kept hitting him and at one point used a club or something similar striking him in the head.

DAY then said the female told him she was sorry and got him a towel and applied pressure to his neck. DAY said the female informed him she would transport him to a hospital if they used his vehicle. DAY said they got into his vehicle but at this time he was in and out of consciousness. He stated they drove around for close to three hours. DAY stated the female told him if he told the police he was going to die and she would just tell them he beat her up. DAY stated in his vehicle and in the apartment there will be a lot of blood. When I was talking with DAY he was coherent and able to follow along with our conversation. He appeared to know what was going on. I asked DAY if he gave the female

consent to stab him or hurt him, he stated he did not. I asked him if his wounds caused him pain, he stated they did. I asked DAY if I could take some photographs of his wounds. I was able to take some overall photographs regarding his wounds. I was unable to take a photograph of the large entrance wound upon his lower neck due to medical bandages that I was advised shall not be removed at this time from medical personnel.

DAY then needed to be seen by medical staff and undergo further testing. The emergency room doctor was contemplating a surgery for the victim at this time due to the severity of the wound to his neck.

Dispatch then advised a black female had walked into St. Mary's Hospital in Green Bay with lacerations to her arms that could be connected with the incident I am currently on. I requested dispatch send Green Bay officers to St. Mary's and locate that female along with seeing if they observe the 2014 Chevrolet Equinox in the parking lot. A short time later I was advised the female who entered St. Mary's Hospital had arrived in a Chevrolet Equinox with Wisconsin registration of BRWCRW.

I then asked DAY if he would be willing to provide me with a quick written statement going over the altercation that had transpired this evening at the apartment in De Pere. DAY stated he would. It should be noted in speaking with DAY he was able to still follow along with our conversation and did not have trouble speaking or keeping a conversation with me.

SUMMARY OF STATEMENT FROM DAY:

I am voluntarily giving this statement to Officer Mrstik of the De Pere Police Department. A female answered my ad on Craigslist for companionship for the evening on Sunday morning around 2am. I responded Sunday midday to say I was free all day Sunday to hang out. She replied and told me to go to Festival in De Pere and let her know when I was there. When I got to Festival I made contact with her she told me to drive north on 10th St. toward the brick apartment buildings that were on the right side of the road. I was on the phone with her and she told me to park in the lot between the apartment buildings and she would be waiting on the patio for me. I got into the lot parked and saw a black female with poofy hair standing on a patio. The female told me she was 24 years old. I think she weighed 175 pounds. She walked me into her apartment and into her bedroom. There was a large white dog in her apartment as well. When we got into the bedroom I took all of my clothes off except my underwear. She had no shirt on. I laid on her bed and she knelt down on top of me. We started kissing. She pushed me, leaned over me and stabbed me in the throat and neck. I started pushing off of her. I pulled the item she stuck in my neck out and tossed it on the ground. We started fighting. She was hitting me in the face with something like a baseball bat. Lights came on, she apologized and got me towels and applied pressure. Told me she would get me to a hospital. We got in my car and she just drove around for 3 hours. I don't know where we went. I fell asleep or passed out. She then dropped me off at Bellin Hospital and took off. I walked into emergency room screaming for help. She told me if I called the police I will die.

END OF SUMMARY OF STATEMENT FROM DAY.

I went and spoke with the emergency room doctor again. He advised me the Ear Nose and Throat specialist was on his way to perform a procedure on DAY. The doctor further advised DAY had several lacerations and abrasions upon his body. The main wound was an approximate 7"-9" puncture stab wound that was just below and to the side of his neck. The emergency room doctor informed me the stab wound was within millimeters of the patient's trachea. The emergency room doctor also stated because the stab wound came so close to the patient's trachea it may have cut the trachea slightly, that injury was still undergoing testing. The emergency room doctor indicated the stab wound went from the front of his person to almost out the back of his person. The large puncture stab wound went into the back muscles of DAY. The emergency room doctor further indicated the trachea of DAY may be punctured as there is a fill up of air bubbling from his chest and neck area but they will not know the extent of those injuries until the ENT specialist finishes his procedure. I cleared the scene.

Detective Guth's reports include the following:

On 07-25-16, I, Detective Sergeant Matthew Guth, was requested by Sergeant Ryan Glime to assist with a stabbing investigation. Sgt. Glime told me that De Pere Police Officer Nathan Mrstik was currently at St. Vincent Hospital with a male subject, Kevin Day, who stated he was stabbed by a female he met through Craigslist. Sgt. Glime stated the female also took the male's vehicle, however the female was now present at St. Mary's Hospital and also present was the vehicle.

At 5:10 a.m., I spoke by phone with Officer Mrstik, who briefed me with information he had available at that time. At 5:35 a.m., Officer Benjamin Giese and I arrived at St. Mary's Hospital, 1726 Shawano Av., City of Green Bay, and met with Green Bay Police Officer Mike Rahn, who stated he was dispatched to the Hospital for a female that presented herself with apparent lacerations to her extremities, and told medical staff she "stabbed" a guy. Officer Rahn identified the female as Octavia M. Lindsey (b/f 01-10-91). Officer Rahn stated the female was also present with a child that she identified as her child. I was provided discharge documents by St. Mary's medical staff, which described Lindsey was treated for "laceration repair" by Christopher C. Thompson, MD.

I met with Lindsey in a private room within the Emergency Department where I identified myself. I identified myself to Lindsey and asked what happened. Lindsey stated she "stabbed a guy in defense". I asked what she meant. Lindsey stated she was "attacked" and she "defended" herself. I observed that she had bandages to her hands, and asked how she was injured. Lindsey again stated she "defended" herself. I asked Lindsey for further details but she was evasive stating only she responded to a Craigslist posting, he came to her house, and "I'm the victim".

I told Lindsey that I wished to speak with her further at the De Pere Police Department, and requested for family contacts to make arrangements for her child. Lindsey refused to provide any name or contact information. I asked Lindsey for information about the child she was with, but would only state it was her "son" and his name was "Blaine". I told Lindsey the importance of trying to make arrangements for her child as he cannot accompany her to the De Pere Police Department. Lindsey refused, at

which point I told her I would need to contact Child Protective Services. Lindsey became agitated questioning why "CPS" had to be involved. I told Lindsey that she was being taken into custody, and would be placed in handcuffs. Officer Giese and I then began to attempt to place her into handcuffs, at which time she tensed her muscles in her arms and attempted to pull them away from us. Officer Giese and I were able to gain control of Lindsey and place her into handcuffs. Lindsey was transported to the De Pere Police Department by Officer Giese, while I awaited arrival of Brown County Child Protection who took custody of Blaine.

At 6:53 a.m., I conducted an audio/video recorded interview with Lindsey at the De Pere Police Department. The following is a synopsis of the interview. I told Lindsey her constitutional rights, which she stated she understood. Lindsey denied she was under the influence of any drugs, alcohol, medication, or anything else that would impair her ability to understand our conversation. Lindsey confirmed she lived at 502 N. 10th St., Apartment #67. I asked if her phone number was 609-5203. Lindsey stated no, she doesn't have a phone. I asked how she communicated with the guy she met on Craigslist. Lindsey stated her iPad which was still at her house. Lindsey stated she lives by herself with her son. I asked the child's father's name. Lindsey stated if I don't have it, I don't need it. I asked if it was Allan Everton. Lindsey stated no. I asked if that is not the child's father. Lindsey asked what does it matter. I told her I was trying to determine the child's father. Lindsey again asked what it has to do with this. I told her I was ensuring her child was being taken care of. Lindsey stated "they" already said her sister has the child. I told Lindsey that is not accurate. Lindsey told me to not raise my voice and I've done more than enough to disrespect her. Lindsey asked what she is being charged with, and if she isn't being "charged" with anything, she can go home. I told her she is not going home. Lindsey asked what she did. I told her that is what I need to hear from her. Lindsey stated "I defended myself". I asked what she defended herself for, as I see she has some injuries. Lindsey again stated "what am I being charged with".

I told Lindsey she is claiming she defended herself, but not providing any details. Lindsey stated "someone tried assaulting me with a knife". I asked how. Lindsey stated "trying to take the knife". I asked how he ended up with stab wounds on his body. Lindsey stated he didn't have stab wounds all over his body. I asked if he had any stab wounds. Lindsey stated "I tried to cut him, he had a little cut, but that is it". I asked if she said a "little cut". Lindsey stated yes. I asked if that is all he had. Lindsey stated yes. I asked why is there blood all over her house, his car, and her clothing. Lindsey stated from her. I asked from what, and if it was her blood. Lindsey asked what I am asking. I told Lindsey that she is not telling me much, and is not consistent with what he is saying. Lindsey asked who. I said the person she stabbed. Lindsey asked his name. I told her to tell me. Lindsey stated if she knew, she would tell me. I asked Lindsey to tell me everything about him. Lindsey asked again what she is being charged with. I told her attempted homicide. Lindsey stated she was defending herself. I told her she is not telling me anything that would show she was defending herself and I need details. Lindsey stated she doesn't have to tell me anything because this state is garbage. Lindsey stated I'm the investigator and I should know everything. Lindsey stated she has more cuts than he does.

I asked for consent to search her residence. Lindsey stated no. I asked what injuries she has. Lindsey stated she has a "gash" on her right hand and asked about what the hospital said. I told her she had lacerations. I asked again about this person. Lindsey stated "no" and I should know. Lindsey said she got "messed up more than he did" and "he is lucky I didn't kill him". I asked if that was her intention. Lindsey stated no, but if she is being assaulted and defends herself, she has every right to kill him. I asked again for details on how she defended herself. Lindsey stated she "tussled with him with the knife". I asked where he got the knife. Lindsey stated from her kitchen. Lindsey stated they came in through the patio, she asked him if he wanted a water, he took a water, and then they walked into the back. I asked if the guy had a nickname. Lindsey stated no. I asked what he looked like. Lindsey stated white. I asked what else, such as was he big, little, short, or tall. Lindsey stated big.

I asked how she got to the hospital. Lindsey she drove there. I asked whose car. Lindsey stated "you know something and not telling me". I asked again whose car. Lindsey stated she didn't have to answer this anymore. I asked how he got to the hospital. Lindsey stated she drove him. I asked driving whose car. Lindsey stated she isn't talking anymore. I asked why not. Lindsey stated because she is being charged with something that she believes she defended herself. Lindsey stated she figured this was going to happen because she is a totally different color. I asked if that is really what she believes this is about, and not that he is in the ICU of a hospital. Lindsey again asked for his name. I told her to tell me. Lindsey stated she doesn't know.

I asked what kind of knife it was. Lindsey stated it would normally be in a wooden thing that all the other knives came in. I asked what the knife looked like. Lindsey stated she didn't know as "it was dark". I asked what was dark, if it was her apartment. Lindsey stated she is done talking. I asked why. Lindsey stated because I'm making it like it is her fault. I told her I'm just asking questions. Lindsey stated she doesn't like the vibe I'm giving her. Lindsey stated he attacked her. I asked how. Lindsey stated with a knife, and she is again done talking. I asked if he is a big guy. Lindsey stated "not too big". I asked if he is bigger than her. Lindsey stated yes. I asked how she got him into the car. Lindsey didn't respond. I asked if someone helped her. Lindsey again didn't respond. I asked if she responded to his ad, with the intention of hurting him. Lindsey shook her head no. I asked if she stole from him. Lindsey shook her head no. I asked if she took him to the hospital because she felt bad about what happened to him. Lindsey nodded her head in acknowledgement. I asked if he deserved to be stabbed. Lindsey didn't respond. Lindsey stated this is a racist state and how "you people handle stuff". I asked Lindsey what she meant by that, and those words are disrespectful. Lindsey didn't respond. I told Lindsey that I'm trying to get her side of the story, but she isn't telling me anything other than making accusations of me. Lindsey stated no, she just needed someone to talk to, and he took advantage of that. Lindsey stated she first started talking to him a few days ago. I asked again to tell me about how she defended herself. Lindsey didn't respond. I told her that it seems like she has a guilty conscience. Lindsey stated no.

I asked if she did something to him that would cause him to attack her with a knife. Lindsey stated she didn't want to fuck him. Lindsey stated she told him that, and he got

angry. Lindsey stated he said that is what you do when you respond to someone on Craigslist. Lindsey stated "I fucked up" and should have never been in contact with him. I asked if any of their previous conversations, did they talk about having or not having sex. Lindsey stated not that she remembers. I asked if he was ever in her bedroom. Lindsey stated yes, they were looking at videos on YouTube. I asked where she first defended herself. Lindsey stated in the bedroom. I asked to tell me about that. Lindsey stated "nope". I asked why not. Lindsey stated it doesn't matter. I asked if there is anything else she wants to tell me or I should know. Lindsey stated there is a lot. I asked to tell me about that. Lindsey stated not to me. Lindsey displayed her right forearm where she had two lacerations. I asked if that is from this incident. Lindsey stated yes.

At 7:24 a.m., Lindsey requested I return to the room and stated she didn't want to go to jail for defending herself and wanted to talk. Lindsey stated they were supposed to hang out and there was talk of "doing it", but she hadn't done it in a long time. Lindsey stated he called her when he got to Festival, and directed him to her house. Lindsey stated he came in, she offered him water, and that's when he must of gotten the knife. Lindsey stated they watched videos. Lindsey stated she trusted him and she needed a new car. Lindsey stated he tried to kiss her, she pushed him back. Lindsey stated he tried kissing her again, she pushed him back again. Lindsey stated that is when he "lunged" at her and they basically fought. Lindsey stated while tussling around on the floor of her room, "I stabbed him". Lindsey stated she wanted to protect herself. Lindsey stated she stabbed him once. Lindsey stated when they were tussling she "was on top of him and stabbed him". Lindsey stated he got her off of him, he opened the door, and was trying to leave. Lindsey stated he said he was going to call the police, and she would lose her son. Lindsey stated she said she would tell them he tried to assault her. Lindsey stated he said that she is just some little black girl. Lindsey stated she said she can't go to jail and said she will still tell that he tried assaulting her. Lindsey stated that is when he offered to give her his car and he kept saying he didn't want to die. Lindsey stated she offered to take him to the hospital. Lindsey stated she was going to take him to a different city. Lindsey stated he "was ok" in the car.

Lindsey stated while in the house, he was bouncing off the walls asking why she did this to him. Lindsey stated she helped him out of the front door. Lindsey stated he initially tried going out the patio door and got blood on it. I asked why she just dumped him off at the hospital. Lindsey stated because she didn't want him to lie to the police. I asked if that is why she just took off. Lindsey stated yes, she wanted to be back with her son. I asked where was her son. Lindsey stated at home. I asked if she left him there. Lindsey stated for a little bit. I told her she left him for a couple hours. Lindsey stated no. Lindsey stated just a little bit to take that guy to the hospital. Lindsey stated she used an app on her iPad to talk on the phone with him. Lindsey stated he had his number on his ad, and she responded with a texting app, Textfree. I asked for the passcode for her iPad. Lindsey stated it was "xxxxxxx". I asked, after she stabbed him, if he tried leaving and she tried stopping him. Lindsey stated she didn't stop him. I asked if she stabbed him more than once. Lindsey stated just once. I asked how he got other injuries. Lindsey stated she doesn't know of any others. I asked where she stabbed him. Lindsey stated believes it was the neck. I asked

if she hit him with something else. Lindsey stated not that she knows of. I asked if her dog bit him. Lindsey stated he was there "trying to help me". I asked why she didn't call the police. Lindsey stated because she didn't think she would be believed. I told Lindsey that is an easy answer when she knows she was in the wrong. Lindsey stated she was defending herself. I asked where the keys were for her apartment. Lindsey stated they would be in her jacket. I told her I have her jacket. Lindsey stated she doesn't know his name, but he did "give me his wallet" when she was taking him to the hospital. Lindsey stated she wanted to call the police, but he wanted to go to the hospital. Lindsey stated she "didn't trust him" because he just tried assaulting her. I asked why she didn't trust him but she went driving around in a vehicle with him. Lindsey stated to let her finish. I told her a person that is fearing for their safety is going to call 911, go to a neighbor, or call someone, not drive around with that person that just attacked him. Lindsey stated he wasn't able to do anything at that point.

I asked where else she took him. Lindsey stated to the hospital. I asked if she took him straight to the hospital. Lindsey stated no that she didn't know where it was. I asked where she went. Lindsey stated she was trying to figure out where the one in De Pere was. I asked if she didn't bother to stop, ask or call. Lindsey asked why she would stop. I asked because she has someone in her car bleeding to death, that she is afraid of and that attacked her, but she is going to go driving around with him for a couple hours and dump him off. Lindsey stated she didn't drive around for a couple hours. I photographed injuries to Lindsey's right forearm. Lindsey stated she had injuries to her left arm, although I could only observe an abrasion to her upper left arm, which was also photographed. Lindsey stated she had an injury to her left armpit area, however did not want me to roll up her sleeve to view it.

After Lindsey was conveyed from the Department, I inspected her clothing to remove the keys to her apartment. In a side pocket of her black jacket, was a brown wallet with a debit card for Kevin Day. Currency in the amount of \$22 was also present in the wallet. Keys to a Chevy vehicle and another bi-fold identification holder containing identification for Kevin Day were also present in this pocket.

At 10:55 a.m., I executed the search warrant to apartment #67 by use of keys that I previously removed from the jacket of Lindsey. The apartment consisted of two bedrooms, one of which was apparent was consistent with being a child's room. This room appeared void of anything remarkable for this investigation, including any blood like staining. However, the remainder of the residence, including every room, there was blood like staining present. The staining was extensive on the floors, walls, and in some locations, ceiling. The staining consisted of pooling, contact stains (swipes or wipes), and cast off or spatter staining. Evidence of attempts to clean locations, specifically pooling within the kitchen floor and on the carpet of the living room were present. Due to the extensive nature of staining throughout the residence, interpretation of events or timeline is unlikely at the time of this report. Also complicating interpretation of blood staining was the presence of the animals in the residence prior to the search, and attempts to contain the animals disrupted various items present in the residence.

Attempts to clean the staining were evident due to a blood like soaked mop and towels, and carpet cleaning like powder present in the living room. Present on the floor of the kitchen was a knife set in a butcher block, missing several knives. This appeared consistent with Lindsey's statements of knives in a block of wood. Present in the master bedroom, on a storage cabinet along the south side of the room, were two knives (Items #16-561-1 and 561-2). Both knives had blood like staining present, and appeared consistent in design with other knives found in the wooden block in the kitchen. An Apple iPad was present on a shelf along the west wall of the master bedroom. The device had extensive blood like staining on it. An additional laptop, tablet, and cellular phone were also present in this room. A vice clamp tool was present on a chair in the master bedroom. The tool also had extensive blood like staining.

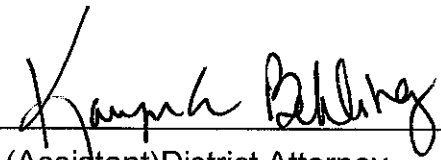
On the floor in the center of the room, near the bed were a pair of size 15 Nike tennis shoes. On the mattress in the master bedroom, was a fluorescent t-shirt. While both items had apparent blood like staining on them, the staining did not appear consistent with a person having worn the items that would have suffered a significant stab/puncture/laceration, when compared to the staining throughout the residence. A pair of damaged and blood like stained glasses were present on the mattress. The mattress was covered in a fitted sheet with apparent patterned blood like staining. Present along the west wall of the master bedroom, was what appeared could be consistent with cast off blood like staining (an object which contained liquid being swung and the liquid being "cast" off due to the motion). This location of this wall was near the mattress and likely consistent with being the head of the mattress, as a television was located at the other end (foot) of the mattress. The collected items I conveyed and submitted into evidence storage at the De Pere Police Department. Photographs of the scene will accompany this investigation.

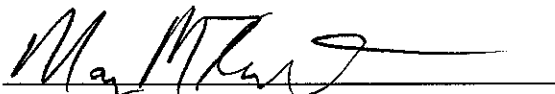
The complainant further asserts that based upon her review of the attached reports and/or supporting documents, the incidents alleged occurred in Brown County, Wisconsin.
