CRIMINAL COMPLAINT

For Official Use

Complainant, an Deputy District Attorney, being first duly sworn on oath, deposes and says that:

Count 1: ARMED ROBBERY, REPEATER

The above-named defendant on or about Tuesday, March 2, 2021, in the City of Green Bay, Brown County, Wisconsin, with intent to steal, did take property from the person or presence of the owner, Superior Discount Liquor, by use or threatening use of a dangerous weapon, contrary to sec. 943.32(2), 939.62(1)(c) Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

And further, invoking the provisions of sec. 939.62(1)(c) Wis. Stats., because the defendant is a repeater, having been convicted of felony Violation Sex Offender Registry in Winnebago County, IL on or about January 8, 2018, which conviction(s) remain of record and unreversed, the maximum term of imprisonment for the underlying crime may be increased 6 years if the prior conviction was for a felony.

Count 2: OBSTRUCTING AN OFFICER, REPEATER

The above-named defendant on or about Tuesday, March 2, 2021, in the City of Green Bay, Brown County, Wisconsin, did knowingly obstruct an officer, while such officer was doing an act in an official capacity and with lawful authority, contrary to sec. 946.41(1), 939.62(1)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

And further, invoking the provisions of sec. 939.62(1)(a) Wis. Stats., because the defendant is a repeater, having been convicted of felony Violation Sex Offender Registry in Winnebago County, IL on or about January 8, 2018, which conviction(s) remain of record and unreversed, the maximum term of imprisonment for the underlying crime may be increased to not more than 2 years.

Complainant is an Deputy District Attorney with the Brown County District Attorney's Office and knows of the above offense(s) on information and belief based upon:

PROBABLE CAUSE:

The complainant, being duly sworn on oath, swears that she has had the opportunity to review the police reports of the Green Bay Police Department and other documents supporting this complaint, which are the types of reports and documents kept in the ordinary course of business, which complainant believes to be truthful and reliable because they have proven to be truthful and reliable on numerous occasions in the past.

The complaint further asserts that based upon her review of the reports and/or supporting documents, the incidents alleged in Brown County, Wisconsin.

1. Your complainant's review of the reports of Officer Scott Salzmann of the Green Bay Police Department, who indicates: On 03-02-21 at approximately 18:16hrs, I was on full uniform patrol in the City of Green Bay assigned to district 2C3K when I was dispatched to Superior Liquor, 2295 Manitowoc Rd, City of Green Bay, Brown County, Wisconsin for a report of a Robbery that had just occurred. As I was responding, dispatch advised a black male had a gun and just robbed the complainant and was last seen heading on foot towards the China Buffet. Further notes indicated the male had the gun in his pocket and then pointed it at the complainant's face and took about \$300 to \$400 dollars and then left on foot. No injuries were reported and the black male was described as being about 5'02" last seen wearing a black jacket and a red hoodie.

Upon my arrival, a witness was located outside who advised they observed this male running out of the store and followed him to a silver van and then followed the van towards Mason/Lime Kiln area. Officer Brentenson identified this male and obtained a written statement from him.

Due to the fact there was a confirmed witness statement seeing this male get into a vehicle, I did not attempt a track and entered the store. I was advised by clerks that the manager was en route to view video footage and possibly get a better clothing description. A short while later, the manager arrived on scene, and I entered the office and reviewed video footage with him. At approximately 18:20hrs, a silver van is observed entering the lot and driving towards the China Buffet. The van went out of view and approximately one minute later, a black male wearing a black jacket with red sleeves, a black hoodie, a black and white bandanna over his face and stone wash jeans with dark colored boots came walking into camera view from the area where the van was last seen. This black male then entered the store at approximately 18:22hrs and stayed near the front of the store. He eventually grabbed a bag of Cheetos and walked to the counter. He was not wearing any gloves and he placed the bag of Cheetos on the counter. While he was waiting for the clerk to open the register, it appeared as though he placed his right hand on the counter top and when the cash register opened, this black male retrieved a black handgun from his left pocket/waistband area and pushed the barrel of the gun to the left temple area of the female cash registered. She startled and moved backwards and he began reaching into the cash register and pulling out money. He continued to point this black handgun at the clerk and after several seconds, he took off running out of the front of the store. The exterior camera showed him running back

towards the way he came, and based on the witness statement, this black male got into the silver van and left towards Auto Plaza.

I remained on scene until Det. Brey and Det. Waln arrived on scene. I briefed them on the information I obtained from the video and showed them where possible evidence would be located within the store. I also took a photo of the subject from the still frame of the video and emailed that photo out department wide for a quick reference in case anyone came into contact with a male matching the clothing description.

2. Your complainant's review of the reports of Det. Max Waln of the Green Bay Police Department, who indicates: On March 2nd, 2021, at approximately 6:15pm, I was working the main register behind counter at Superior Discount Liquor. I saw a customer come in the west facing door of the store. The customer was a short black male, approximately 5'12" in height and approximately 140 pounds. He was wearing a red hooded sweatshirt with a black, spring jacket over it. The male had brown eyes, but I could not see his hair because his red hood was covering it.

This customer walked in and walked right to a bag of chips. He grabbed a large bag of Cheetos in a blue and orange bag. Once this male had the Cheetos in his hand, he walked to the register. I told the male that his total was \$3.99 and he pulled a \$10 bill out of his pocket and placed it on the counter. I grabbed the \$10 bill and opened the till; when I was grabbing the male's change, I felt something cold and hard pressed on my cheek. I looked to see what was on my cheek, and I saw the male holding a gun against my face. The gun was approximately 8-9" in length and possibly a .45 caliber. The male was holding the gun with his right hand; he had it pressed against my cheek, pointed towards my face.

The male said, "Give me all your money." The male appeared to be younger, as his voice sounded younger. I then froze and the male reached over the counter with his left hand. He began to take money from the still-open till and place it into his left jacket pocket. I believe the male took between \$300-400 in cash. The male then ran to the west-facing door of the store and began to run north in the parking lot and I lost sight of him.

I then went to my coworker and told him that I was just robbed. When the male had the gun to my face, I feared for my life and believed he would have killed me if I did not cooperate.

3. Your complainant's review of the reports of Det. Max Waln of the Green Bay Police Department, who indicates: On 3/2/21 I was working second shift as a detective. At approximately 1820 hours, I was notified by the patrol shift commander of an armed robbery at Superior Discount Liquor, 2295 Manitowoc Rd, Green Bay. Dispatch took a report of a black male with a handgun who robbed the liquor store cashier and left on foot with approximately \$300-\$400 dollars. The suspect reportedly pointed the gun directly in the cashier's face. Additional information was reported that a witness saw the suspect go to a silver minivan, possibly a Chrysler Town and Country.

Detective Brey and I listened to the 911 call of the incident prior to responding. I later placed the 911 audio into the audio section of this report. Detective Brey and I were briefed by Sgt Jordan and officers on scene. I watched the security camera video of the incident from multiple different camera angles. I observed a black male suspect wearing a dark colored "Akoo" black flag varsity jacket with orange sleeves, light colored blue jeans and brown boots enter the

liquor store. The male did not appear to touch the double doors on the way in due to them being automatic. The male was not wearing any gloves. I saw him grab a bag of Cheetos of the rack near the counter then go around to the cashier. The suspect put the Cheetos on the counter and put his right hand down on the counter briefly. The suspect pulled a dark colored handgun from his left waistline area and held it with his left hand. The suspect extended his arm and pointed the gun directly at the cashier 's face. At that time the cashier had the drawer open. The suspect reached in and removed several bills then left the store out of the liquor store exit. The exits doors opened automatically but it appeared the suspect may have pushed the doors open as well to exit faster.

I took a photo of the suspect showing the back of his jacket with logo, "Akoo " and emailed that to other officers to add to the email already sent out showing the front view of the suspect's jacket. I then was showed video of a silver looking minivan entering the liquor store parking lot from the frontage road to the south. The van drove north, in front of the liquor store and appeared to park facing east just out of camera view to the north of the liquor store, possibly by the East branch library. This van appears to match the description a witness gave as he saw the suspect leaving the scene in a silver Town and Country van.

I walked the outside parking lot area to look for anything left behind by the suspect or additional security cameras. Tips 2 Toes Nail Salon directly to the north of the East Branch Library appears to have an exterior camera that could possibly have captured the suspect vehicle after the robbery. I did not see any other evidence.

I then met with Kristen from IFSU and briefed her on what happened and what was potential evidence for fingerprints and DNA swabs to include the bag of Cheetos left on the counter, the counter next to the Cheetos, the cash drawer, the exit doors and a vape on the ground just outside of the exit doors. I also requested a copy of the security camera footage inside and out. Patrol Officer stood by while we collected those items.

Detective Brey and I then drove the area of the suspect 's last known locations and checked several apartment parking lots and neighbor hoods for a vehicle matching the suspect's vehicle but were unable to locate any. I spoke to Lt J. Allen and requested a Nixle alert be sent out to the public in attempts to identify the suspect based on his clothing. I checked GERP and CAD for any contacts or reports with "Akoo " or similar jacket descriptions but could not locate anything. At this time, neither the suspect nor the vehicle has been identified.

4. Your complainant's review of the reports of Officer Nicholas Walvort of the Green Bay Police Department, who indicates: On 3/3/21 at approximately 1845 hours I, Officer N. Walvort, was on uniformed patrol, as unit C5D3, in the City of Green Bay. I had received information that detectives were looking for a suspect vehicle, a silver Dodge Caravan bearing Wisconsin registration #AJY3154, and a suspect, Lawrence Jamar Watkins (9/1/83), in reference to an armed robbery. Watkins had a temporary felony warrant for his arrest.

I was traveling westbound on E Mason St at Bellevue St when I observed the vehicle traveling eastbound. I notified dispatch that I had observed the vehicle and was attempting to turn around. When I turned around I attempted to catch up to the vehicle. Detective Brey was in the area of 800 Lime Kiln Rd, which was Watkins' address, and a short time later he stated that the suspect vehicle had pulled into the parking lot. I pulled into the parking lot and observed someone still sitting in the driver seat. I got out of my vehicle and ordered the

driver to show me their hands. I could hear him talking and realized that the driver matched the description of Watkins. Detective Brey and I were able to get Watkins prone out on the ground until Sergeant Obrien arrived and he was detained. I assisted with searching Watkins and he was then placed in the back of Sergeant Obrien's vehicle.

Several individuals had exited apartment #5, which was Watkins' apartment. We informed them that we would be securing the residence to obtain a search warrant. Ultimately we were allowed inside and the residence was secured so further investigation could be completed. I was asked by Detective Brey to take photographs of a gun within a clothes bin in the second story, northeast bedroom.

5. Your complainant's review of the reports of Sgt. Erik O'Brien of the Green Bay Police Department, who indicates: On Wednesday, March 3, 2021 at approximately 1845 hours, I, Sgt. O'Brien, was in full uniform operating a fully marked squad car when I heard Officer N. Walvort call out with a suspect vehicle that had been associated with an armed robbery related to this case. Officer Walvort indicated that the vehicle was eastbound on Mason Street and that it was possibly approaching the suspected home address of the robbery suspect. I then heard Officer Walvort and Detective Brey call out that they had the vehicle stopped and were attempting to take the driver into custody.

When I arrived on scene the driver of the vehicle who was identified as **Watkins/Lawrence/J. (09/01/83)** was prone out next to the driver's seat of the vehicle. I assisted Officer Walvort and Detective Brey with clearing the vehicle and I took Lawrence into custody. I placed Lawrence into handcuffs which were checked for tightness and safety locked. I then assisted Lawrence to his feet and escorted him back to my squad car so he could be searched and placed in the back of my vehicle. During my contact with Lawrence he was verbally argumentative and just kept saying he didn't do anything and then while I was trying to escort him to my squad car he attempted to ground his feet not allowing us to move forward.

Once at my squad car, Officer Walvort and I performed a systematic search of Lawrence and we removed some personal property from his pockets and I located in his front left pocket that was over his knee in his pants a large sum of cash. I placed all of Lawrence's property in a plastic bag and Lawrence was seated in the back seat of my squad car.

I then assisted Detective Brey by informing the residents at 800 Lime Kiln Road #5 which was the destination Lawrence was headed to when he was stopped that officers were going to be securing the apartment as they either sought a search warrant or consent to search from the property owner. The occupants of the residence were argumentative, but ultimately cooperative. We entered the residence, assisted the family members with gathering belongings for their children and escorting them outside to a vehicle. A protective sweep of the residence was performed and no additional people were located inside. While we were helping the residents inside gather some belongings for the children, I heard Detective Brey ask one of the females about a jacket that the suspect was viewed wearing in the video described as an AKOO jacket and one of the females answered Detective Brey saying that he was wearing that jacket and she remembered seeing it the other day. They also directed Detective Brey to the location of a firearm inside the residence, but they were advised not to go near it and not to touch it. Once all the occupants were escorted out of the residence and Detective Brey had enough officers with him to secure the residence until either consent or a warrant was granted. Prior to leaving the scene I turned over Lawrence and his property.

Lawrence was placed in the back of Officer Stevens' squad car and the property was given to Detective Brey.

6. Your complainant's review of the reports of Det. Craig Brey of the Green Bay Police Department, who indicates: On 03/03/2021, I, Detective Brey, of the Green Bay Police Department was advised that Green Bay police traffic Officer Childs had observed a silver vehicle that matched the description from the robbery the day previous and the vehicle was being driven by a male black who he was able to associate to the vehicle which had a plate of AGY3154 and it was a silver 2001 Dodge Caravan that came back to S.L.W. (02/12/84), 800 Lime Kiln Road #5. I noted this is the area of the robbery and Lime Kiln Road was the last known location of the vehicle by a witness from the robbery yesterday. Officer Childs was able to link this vehicle to Lawrence Jamar Watkins (09/01/83) who has the weight of 5'4", 140 pounds, black male which would match the physical description from the robbery from the day before. Based on this information, myself and Detective Waln discussed how we were going to investigate this. Detective Waln and I determined I would sit on the residence of 800 Lime Kiln Road, Apt. #5 in an attempt to try and make contact with the vehicle while Detective Waln would go to Lawrence Watkins last known place of employment.

After Detective Waln had made contact with Lawrence's last known employer it was determined that Lawrence was a likely suspect in this robbery and a temporary felony warrant was placed for his arrest for armed robbery. Based on this information from Detective Waln, I was sitting on the apartment when Officer Walvort stated that the vehicle was traveling eastbound on Mason Street. At this point I positioned my vehicle to the west of the apartment complex and was out on foot. I observed the vehicle pull into the parking lot and Officer N. Walvort initiated a traffic stop on the vehicle and we conducted a felony stop and took Lawrence into custody without incident. There was a female who interfered at the arrest and I will be referring charges reference another Green Bay police report number.

Lawrence was taken into custody without incident. I then contacted the owner of the vehicle S.L.W. and she arrived on scene and she gave consent for the vehicle, her apartment and the black iPhone that she said she paid for that was found on the driver's seat of S.L.W.'s vehicle that Lawrence was using. Once Lawrence was taken into custody he was searched by Sgt. O'Brien who located approximately \$507.45 in Lawrence's left front knee pocket.

I made contact with three people inside and a child of Apt. #5 at 800 Lime Kiln Road. I explained to the two children that were inside the residence, **C.R.W. (09/22/03)** and **J.S.W. (08/19/06)** about the investigation and I showed J.S.W. a picture from the surveillance video of Lawrence committing the robbery. J.S.W. immediately admitted that was Lawrence in his AKOO jacket which she wasn't sure where it was. She said he normally keeps at the house but she couldn't find it.

I then explained the investigation to S.L.W. who stated she knew that he had committed the robbery because she stated this morning at 5:00 a.m. she went her client's house. She was watching the news. She saw Lawrence on the news at the cash register with his jacket on and she stated it's a black jacket with multiple colors. When she got home at about 12:30 p.m. on 03/03/2021 she confronted Lawrence about what she saw on the news. She said Lawrence immediately told her that he does not know what he was thinking and it was just a BB gun and he no longer has the gun. S.L.W. stated she was trying to tell Lawrence to clear this up

because is it an armed robbery and she said he was sorry and asked for mercy on his soul. S.L.W. said Lawrence does not know why he did this.

I then placed the following pieces of evidence into evidence which would be four necklaces, a BIC lighter, a Fila face mask, a wallet with miscellaneous cards and Lawrence's ID into Exhibit 583001. Exhibit 583002 was a Victoria Secret receipt that shows on 03/03/2021 Lawrence made a purchase with cash at Victoria Secret. Exhibit #583003 was \$507.45 in miscellaneous denominations located on Lawrence's person by Sgt. O'Brien and the cell phone that was found on the front seat of S.L.W.'s vehicle was listed into evidence under Exhibit #583004.

7. Your complainant's review of the reports of Officer Max Waln of the Green Bay Police Department, who indicates: On 3/3/21, I interviewed Lawrence J. Watkins (9/1/83). Lawrence admitted to robbing the liquor store and admitted that the \$500 he had on him during the arrest was from the robbery. Lawrence 's fiancé S.L.W., gave a written statement about seeing Lawrence 's picture on the news and Lawrence admitting to her that he committed the robbery. Lawrence claimed it was a pellet gun. Officers located a pellet gun at his apartment that matched the gun seen during the robbery.

On 3/3/21 I was working second shift as a detective. At the start of my shift I was given information that a Green Bay Patrol Officer observed a van today matching the description of the suspect van seen at the liquor store reference this investigation. That vehicle was a silver 2001 Dodge Caravan with WI plate AJY3154 registered to S.L.W. at 800 Lime Kiln #5, Green Bay. This is the area that witness K.L.P. last saw the suspect vehicle heading towards right after the robbery. I was told that Lawrence Watkins had recently been stopped as a driver of that vehicle. I checked CAD and found a De Pere incident, 20-111853 from 11/12/20 in which Lawrence J. Watkins (9/1/83) was stopped in a vehicle with WI plate AJY3154. Lawrence 's DOT physicals matched that of the robbery suspect; male/black 5 '4, 140 lbs. I then looked up prior contacts in CAD with Lawrence and found a Theft complaint at a Shell station 2530 Babcock Rd in which Lawrence was accused of theft as an employee.

At approximately 1630 hours, I went to 2530 Babcock Rd in Ashwaubenon and spoke to the manager, K.L.R. . I asked K.L.R. about Lawrence Watkins. K.L.R. told me that Lawrence only worked for her one day and he was caught stealing. K.L.R. said Lawrence was at her gas station yesterday afternoon and talked to her about getting a copy of his liquor license. K.L.R. showed me security video footage from the previous day, 3/2/21, the day of the robbery at Superior Liquor, and showed me a male that she identified as Lawrence Watkins. K.L.R. said she did not recognize him at first but he told her his name was "Lawrence Watkins". I took several photos of the computer screen showing Lawrence driving a silver minivan with a WI plate that appeared to read AJY3154 and photos of Lawrence in the gas station wearing the same jacket and jeans as the Superior Liquor robbery suspect. Lawrence entered the gas station at 12:56 camera time and left at 13:21 camera time.

Lawrence was with a female later identified as the vehicle 's registered owner and his fiancé S.L.W.. I requested that Detective Brey watch the apartment at 800 Lime Kiln to attempt to observe the van or Lawrence at that residence. I returned to the police department and compared the security camera images (3/2/21 6:16 pm) of the suspect at Superior Liquor to the security camera images of Lawrence Watkins at the Shell Station (3/2/21 1pm). I believed it to be the same person based on height and weight and the exact same jacket and jeans. I compared the van (AJY3154) seen at the Shell Station (3/2/21 1pm) that Lawrence was driving

to the suspect van seen on security camera outside Superior Liquor just prior to the robbery and believed them to be the same vehicle.

I had the front desk employee at GBPD enter a temporary felony warrant for Lawrence J. Watkins (9/1/83) and sent out a department wide email and County wide ATL for Lawrence reference the armed robbery.

At approximately 1855 hours, I was informed that Officer N. Walvort saw the suspect vehicle, AJY3154 pulling into the parking lot of 800 Lime Kiln. Officers took the driver into custody and identified him as Lawrence J. Watkins (9/1/83). I went to 800 Lime Kiln to assist Detective Brey. Detective Brey obtained consent to search the apartment, apt #5, and consent to search the vehicle, AJY3154, from S.L.W..

At approximately 2000 hours, I returned to the police department and spoke to Lawrence Watkins in interview room #1, which was audio and video recorded. I identified myself and told Lawrence that I wanted to speak to him about what he was arrested for. I read Lawrence his Miranda Rights word for word off the GBPD Miranda Rights form. Lawrence said he understood and agreed to speak to me. Lawrence initially denied any knowledge or involvement in an armed robbery the previous day, 3/2/21. Lawrence claimed he was at home all day. I showed Lawrence a photo I took of the security camera at the Shell station, 2530 Babcock Rd from yesterday of a male wearing an "Akoo " varsity jacket with orange sleeves. Lawrence admitted that he was that male. I then began talking to Lawrence about the armed robbery at Superior Liquor, 2295 Manitowoc Rd the previous day, 3/2/21. I showed Lawrence a picture of the suspect wearing the exact same jacket. Lawrence ultimately admitted to the armed robbery and told me the following which is a summary and not verbatim: Lawrence was driving his fiancé S.L.W.'s van and went to the Superior Liquor store approximately 5-10 blocks from his apartment, 800 Lime Kiln, Green Bay. Lawrence was stressed about not working and not having money. Lawrence put a bag of chips on the counter then pulled out a pellet gun from his coat or waist and took the cash out of the open register.

Lawrence said it was not a real gun, but a pellet gun that he claimed was not loaded. Lawrence left the liquor store in S.L.W.'s van and threw out his coat, boots and pants he was wearing during the robbery in a dumpster at an unknown location. Lawrence kept the pellet gun and hid it in his kitchen closet. Lawrence did not throw out his belt that he was wearing during the robbery which was the same belt he was wearing during the time of his interview. Lawrence did not know how much money he stole but said the money officer's found on him during his arrest, \$507. 45, was the money he stole from the liquor store during the robbery. Lawrence also admitted to being left handed. I observed Lawrence use his left hand to sign the 2 consent to search forms. This is also consistent with the suspect in the video seen using his left hand to hold the handgun during the robbery.

Lawrence said he was sorry for what he did and said it was out of character. Lawrence denied any drug or alcohol addictions and appeared to be sober at the time of my contact with him. Lawrence gave consent to a DNA buccal swab and signed the consent form. I obtained the buccal swab for Lawrence 's DNA using a new, unopened GBPD buccal swab kit. I wore new, unused evidence gloves and took 2 swabs, one from each side of the insides of Lawrence's cheek. I placed the swabs in an evidence cardboard tube then into a yellow evidence envelope, evidence item 520-001. Lawrence also signed a consent to search his phone found on him during his arrest, evidence item 583-004. I then collected his belt, a black leather belt

size 40 with dual prongs at the buckle with two rows of punch holes, evidence item 520-002. This belt wrapped around Lawrence past the buckle in front and continued around the right side of his body and ended above the middle area of his rear right jeans pocket, which is the same belt and same belt position seen on the suspect in the security video of Superior Liquor during the robbery. I then collected Lawrence 's bandanna that he was wearing on top of his head which was a black bandanna with white designs which appears to be similar to what the suspect wore over his face during the robbery. I put that bandanna into evidence as item 520-003.

Officer Stevens brought me the pellet gun he located at Lawrence's apartment. I showed the pellet gun to Lawrence. Lawrence admitted that the pellet gun was his and that it was the pellet gun he used during the armed robbery he committed at Superior Liquor in Green Bay the previous day. I looked at the gun which was an all-black semi auto style looking handgun. The pellet gun matched the gun seen in Lawrence's left hand pointed at the cashier's face during the robbery. Lawrence was transported by officers to the Brown County Jail where he was charged with Armed Robbery, 943.32(2).

8. Your complainant's review of the records from the Triple I/CIB, indicates that the defendant, Lawrence J. Watkins (d.o.b. 9/1/83), was convicted in Winnebago County, Illinois, Case 17CF2465. Said records indicate that on or about January 8, 2018, there was a disposition in said case with a Judgment of Conviction on a charge of Violation Sex Offender Registry.

Complainant believes the records of the Wisconsin Circuit Court Access Program/Triple I/CIB to be true and accurate in that they are records kept in ordinary course of business and it is within the ordinary course of business to keep said records.

Based on the foregoing, the complainant believes this complaint to be true and correct.
