Dear Judge Kelly

I am Steve Preisler and I write in response to 2023CV1104 filed by the City of Green Bay against me and my house at 826 S. Baird St which they seek to seize. Their filing is so filled with errors as to be a comedy of errors, if it was not so serious.

Most egregious of these series of errors is to be found in Section 19 of their Complaint. The 328.26 grams of methamphetamine listed was actually sodium sulfate, aka silica gel, which I had in my basement to check out the validity of a couple Patents issued in the 1960's describing its use to remove water from 190 proof vodka solutions. I was checking to see if the Patent works as claimed. The answer is yes it does. Why check? Sometimes Patent claims don't work as described.

This same section 19 goes on to claim 114.37 gr of crack cocaine found in that same basement lab. The true identity of this material is potassium carbonate, K_2CO_3 . I had it as a result of trying a new way to make this material, which was to add dry ice to a water solution of KOH inside a 40oz beer bottle and screwing on the cap to hold CO_2 inside. Then simmer down the water to

leave rock chunks of K_2CO_3 I consider
it a pretty slick process.
The same section then goes on to claim
385.78 gr of "unknown controlled substance"
- whatever that is - My guess is the material
is either Bo Peep ammonia detergent or some
food supplement amino acids I was experiment
with.
This then leaves 3.67 gr marijuana weed
and 6 Vigra pills in this big haul they whel
out as justification for seizing my house
and holding me under half million bail. I
think they are out of line and out of
contact with reality.
The State Crime Lab has had samples
of these materials for 2 months now. I was
told 4 to even 6 months is not unusual for
them to look at something.
I urge you to put this filing on hold
until these results come in and further
urge you to give a push to the Crime
Lab to come back with a few results
pertaining to this, (Exhibits 22 through 28
so this filing can then meet its just
end.

I also wish to challenge the original placement of my house on the "nuisance property" list. It was placed there in Sept 2021, and according to ordinance during the previous 12 months there had to be 3 separate instances of listed violations. I am thinking there were not as most calls involved people coming by when I was at work or asleep looking for a place to spend the night or escape the cold. A housemate - Stephanie Tiegs - at that time period had a boyfriend - Jason Barfell - who used to beat her regularly, and I had to call police to rescue her. Those would be instances of assault, a listed crime call - but since I did the calling for help for her, it shouldn't count. I ask for you to Order the City to give me a complete listing of these police calls and their details so that an accounting can be made and determine if I was put on this nuisance list properly in the first place.

This is by no means an exhaustive listing of errors in the complaint - merely a start -> for example in #12 Rebecca was not cited for meth possession.
