The undersigned, being first duly sworn, states that:

Count 1: FIRST DEGREE INTENTIONAL HOMICIDE

The above-named defendant on Monday, September 4, 2023, in the City of Clintonville, Waupaca County, Wisconsin, did cause the death of VICTIM, with intent to kill that person, contrary to sec. 940.01(1)(a), 939.50(3)(a) Wis. Stats.

Upon conviction for this offense, a Class A Felony, the defendant shall be sentenced to imprisonment for life.

PROBABLE CAUSE:

Your complainant is an officer with the Clintonville Police Department. Your complainant makes this complaint upon information and belief and upon reports and records of the Clintonville Police Department. Your complainant has relied upon these records in the past and has found them to be truthful and reliable.

Your complainant has reviewed reports of Sqt. Wright and Officer Arrieta which state:

- On 9/4/2023 at approximately 12:31 PM officers were dispatched to the area of Olen Park, City
 of Clintonville, Waupaca County, State of Wisconsin, for a 911 open line where a female was
 moaning and had previously stated she had been stabbed. Waupaca County Communication
 Center was unable to provide us with a more precise location. At that time, I immediately started
 to go to that area.
- Upon arrival officers saw a male party in a white t-shirt standing by a yellowish color car that
 had the driver side door open. The vehicle was parked on the street near the west exit/entrance
 to Olen Park. When officers arrived on scene they ran the vehicle's license plate ANF-6257
 through Clintonville Dispatch and could see a female laying on the ground in the fetal position
 down the hill below the male.

- The male party was ultimately identified as JORDAN D. PETERS DOB 2/3/2004, Sgt. Wright asked JORDAN if he was the one who called. JORDAN said, "I stabbed her" and he threw a folding knife to the ground by Sgt. Wright's feet.
- Sgt. Wright then went to the female who was later identified as VICTIM. Officer ARRIETA was
 on scene and moved VICTIM to her back and had cut her shirt open to assess her injuries.
 VICTIM was blue in color and having difficulty breathing. Officers visualized a wound,
 approximately one inch in length, in the center of VICTIM's body just below the sternum.
- Clintonville Ambulance and Theda Star were summoned to assist due to the nature of VICTIM's injuries. While VICTIM was being cared for by the Clintonville Ambulance crew Sgt. Wright asked VICTIM "who did this to you?" VICTIM answered "Jordan (VICTIM stated the relationship between VICTIM and Jordan which has been left out of this complaint)... he hates me."
- VICTIM was transported by Theda Star to Theda Care Medical Center in Neenah, WI where she later succumbed to her injuries.
- At approximately 1:56pm Sgt. Wright transported JORDAN to the Clintonville Police Department and placed him into an interview room. After being properly Mirandized, Jordan agreed to answer questions and speak with officers.
- During the interview when asked about what happened Jordan stated "I guess I got really angry and was thinking about the past and got to that breaking point and just stabbed her". Officers asked Jordan why he had the knife with him today and Jordan stated "because I had plans to hurt [VICTIM]." Jordan went on to tell investigators that he had wanted to kill VICTIM for the last year and had begun planning it over the last week.
