The undersigned law enforcement officer of the Ripon Police Department, being first duly sworn, states that:

**Count 1: FIRST DEGREE RECKLESS HOMICIDE - PTAC, AS A PARTY TO A CRIME** (As to defendant Michael R Manske)

The above-named defendant on or about Friday, April 7, 2023, in the City of Ripon, Fond du Lac County, Wisconsin, as a party to a crime, did cause the death of VICTIM 1, by the delivery or manufacture of a Schedule I or II controlled substance, fentanyl, in violation of sec. 961.41 Wis. Stats., which VICTIM 1 used, dying as a result of that use, contrary to sec. 940.02(2)(a), 939.50(3)(c), 939.05 Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

**Count 2: POSSESSION OF DRUG PARAPHERNALIA** (As to defendant Michael R Manske)

The above-named defendant on or about Tuesday, April 11, 2023, Fond du Lac County, Wisconsin, did knowingly possess drug paraphernalia with the primary intent to use a controlled substance, contrary to sec. 961.573(1) Wis. Stats., a Misdemeanor, and upon conviction may be fined not more than Five Hundred Dollars (\$500), or imprisoned for not more than thirty (30) days, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 3: POSSESSION OF TETRAHYDROCANNABINOLS (THC)** (As to defendant Michael R Manske)

The above-named defendant on or about Tuesday, April 11, 2023, Fond du Lac County, Wisconsin, did knowingly possess a controlled substance, tetrahydrocannabinols (THC), contrary to sec. 961.41(3g)(e) Wis. Stats., a Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned for not more than six (6) months, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 4: MAINTAINING A DRUG TRAFFICKING PLACE** (As to defendant Michael R Manske)

The above-named defendant on or about Tuesday, April 11, 2023, Fond du Lac County, Wisconsin, did knowingly maintain a dwelling which is resorted to by persons using controlled substances in violation of chapter 961 Wis. Stats., contrary to sec. 961.42(1), 939.50(3)(i) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 5: FIRST DEGREE RECKLESS HOMICIDE - PTAC, AS A PARTY TO A CRIME** (As to defendant Donavyn James Mueller)

The above-named defendant on or about Wednesday, April 5, 2023, Winnebago County, Wisconsin, as a party to a crime, did cause the death of VICTIM 1, by the delivery or manufacture of a Schedule I or II controlled substance, fentanyl, in violation of sec. 961.41 Wis. Stats., which VICTIM 1 used, dying as a result of that use, contrary to sec. 940.02(2)(a), 939.50(3)(c), 939.05 Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

**Count 6: POSSESSION WITH INTENT TO DELIVER NARCOTICS** (As to defendant Donavyn James Mueller)

The above-named defendant on or about Wednesday, April 5, 2023, Winnebago County, Wisconsin, did possess with intent to deliver a controlled substance, to-wit: Fentanyl, contrary to sec. 961.41(1m)(a), 939.50(3)(e) Wis. Stats., a Class E Felony, and upon conviction may be fined not more than Fifty Thousand Dollars (\$50,000), or imprisoned not more than fifteen (15) years, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 7: POSSESSION OF DRUG PARAPHERNALIA** (As to defendant Olivia A Nordvold)

The above-named defendant on or about Tuesday, April 11, 2023, Fond du Lac County, Wisconsin, did knowingly possess drug paraphernalia with the primary intent to use a controlled substance, contrary to sec. 961.573(1) Wis. Stats., a Misdemeanor, and upon conviction may be fined not more than Five Hundred Dollars (\$500), or imprisoned for not more than thirty (30) days, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 8: POSSESSION OF TETRAHYDROCANNABINOLS (THC)** (As to defendant Olivia A Nordvold)

The above-named defendant on or about Tuesday, April 11, 2023, Fond du Lac County, Wisconsin, did knowingly possess a controlled substance, tetrahydrocannabinols (THC), contrary to sec. 961.41(3g)(e) Wis. Stats., a Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned for not more than six (6) months, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 9: MAINTAINING A DRUG TRAFFICKING PLACE** (As to defendant Olivia A Nordvold)

The above-named defendant on or about Tuesday, April 11, 2023, Fond du Lac County, Wisconsin, did knowingly maintain a dwelling which is resorted to by persons using controlled substances in violation of chapter 961 Wis. Stats., contrary to sec. 961.42(1), 939.50(3)(i) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 10: POSSESSION WITH INTENT TO DELIVER NARCOTICS** (As to defendant Joseph L. Schmidt-Rehbein)

The above-named defendant on or about Friday, April 7, 2023, in the City of Ripon, Fond du Lac County, Wisconsin, did possess with intent to deliver a controlled substance, to-wit: Fentanyl, contrary to sec. 961.41(1m)(a), 939.50(3)(e) Wis. Stats., a Class E Felony, and upon conviction may be fined not more than Fifty Thousand Dollars (\$50,000), or imprisoned not more than fifteen (15) years, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 11: POSSESSION OF NARCOTIC DRUGS** (As to defendant Joseph L. Schmidt-Rehbein)

The above-named defendant on or about Friday, April 7, 2023, in the City of Ripon, Fond du Lac County, Wisconsin, did knowingly possess, a controlled substance included in Schedule I or Schedule II which is a narcotic drug, contrary to sec. 961.41(3g)(am), 939.50(3)(i) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 12: OBSTRUCTING AN OFFICER** (As to defendant Joseph L. Schmidt-Rehbein)

The above-named defendant on or about Thursday, April 13, 2023, Fond du Lac County, Wisconsin, did knowingly obstruct an officer, while such officer was doing an act in an official capacity and with lawful authority,, contrary to sec. 946.41(1), 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

**Count 13: POSSESSION OF DRUG PARAPHERNALIA** (As to defendant Joseph L. Schmidt-Rehbein)

The above-named defendant on or about Thursday, April 13, 2023, Fond du Lac County, Wisconsin, did knowingly possess drug paraphernalia with the primary intent to use a controlled substance, contrary to sec. 961.573(1) Wis. Stats., a Misdemeanor, and upon conviction may be fined not more than Five Hundred Dollars (\$500), or imprisoned for not more than thirty (30) days, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 14: POSSESSION WITH INTENT TO DELIVER THC (TETRAHYDROCANNABINOLS) (>200 - 1000G)**  
(As to defendant Joseph L. Schmidt-Rehbein)

The above-named defendant on or about Thursday, April 13, 2023, Fond du Lac County, Wisconsin, did possess with intent to deliver a controlled substance, to-wit: tetrahydrocannabinols (THC), in an amount of more than 200 grams but not more than 1,000 grams, or more than 4 plants containing tetrahydrocannabinols but not more than 20 plants containing tetrahydrocannabinols, contrary to sec. 961.41(1m)(h)2, 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 15: FIRST DEGREE RECKLESS HOMICIDE - PTAC, AS A PARTY TO A CRIME** (As to defendant Joseph L. Schmidt-Rehbein)

The above-named defendant on or about Friday, April 7, 2023, in the City of Ripon, Fond du Lac County, Wisconsin, as a party to a crime, did cause the death of VICTIM 1, by the delivery or manufacture of a Schedule I or II controlled substance, fentanyl, in violation of sec. 961.41 Wis. Stats., which VICTIM 1 used, dying as a result of that use, contrary to sec. 940.02(2)(a), 939.50(3)(c), 939.05 Wis. Stats., a Class C Felony, and upon conviction

may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

**Count 16: MAINTAINING A DRUG TRAFFICKING PLACE** (As to defendant Joseph L. Schmidt-Rehbein)

The above-named defendant on or about Thursday, April 13, 2023, Fond du Lac County, Wisconsin, did knowingly maintain a dwelling which is used for keeping controlled substances in violation of chapter 961 Wis. Stats., contrary to sec. 961.42(1), 939.50(3)(i) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 17: POSSESSION OF TETRAHYDROCANNABINOLS (THC)** (As to defendant Joseph L. Schmidt-Rehbein)

The above-named defendant on or about Thursday, April 13, 2023, Fond du Lac County, Wisconsin, did knowingly possess a controlled substance, tetrahydrocannabinols (THC), contrary to sec. 961.41(3g)(e) Wis. Stats., a Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned for not more than six (6) months, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 18: FIRST DEGREE RECKLESS HOMICIDE - PTAC, AS A PARTY TO A CRIME** (As to defendant Maison C Springston)

The above-named defendant on or about Friday, April 7, 2023, in the City of Ripon, Fond du Lac County, Wisconsin, as a party to a crime, did cause the death of VICTIM 1, by the delivery or manufacture of a Schedule I or II controlled substance, fentanyl, in violation of sec. 961.41 Wis. Stats., which VICTIM 1 used, dying as a result of that use, contrary to sec. 940.02(2)(a), 939.50(3)(c), 939.05 Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

**Count 19: POSSESSION OF DRUG PARAPHERNALIA** (As to defendant Maison C Springston)

The above-named defendant on or about Thursday, April 13, 2023, Fond du Lac County, Wisconsin, did knowingly possess drug paraphernalia with the primary intent to use a controlled substance, contrary to sec. 961.573(1) Wis. Stats., a Misdemeanor, and upon conviction may be fined not more than Five Hundred Dollars (\$500), or imprisoned for not more than thirty (30) days, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 20: OBSTRUCTING AN OFFICER** (As to defendant Maison C Springston)

The above-named defendant on or about Tuesday, April 11, 2023, Fond du Lac County, Wisconsin, did knowingly obstruct an officer, while such officer was doing an act in an official capacity and with lawful authority,, contrary to sec. 946.41(1), 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

**Count 21: POSSESSION OF TETRAHYDROCANNABINOLS (THC)** (As to defendant Maison C Springston)

The above-named defendant on or about Thursday, April 13, 2023, Fond du Lac County, Wisconsin, did knowingly possess a controlled substance, tetrahydrocannabinols (THC), contrary to sec. 961.41(3g)(e) Wis. Stats., a Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned for not more than six (6) months, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**PROBABLE CAUSE:**

The basis for complainant's charge of said offenses is based on the reports of numerous officers within the Ripon Police Department including Brad Rasmussen and Lindsey Michels, whom your complainant has worked with in the past and knows to be competent and reliable.

On April 7 2023, at approximately 6:30 am, officers of the Ripon Police Department were dispatched to the area of Scott Street and Stanton Street. In the city of Ripon, Fond du Lac County, Wisconsin. There was a report of a male subject lying on the sidewalk. On arrival, officers located a deceased white male, later identified as Victim 1, age 18 years old.

Ripon Police Department SRO Rasmussen reported to the scene and assisted in the investigation. SRO Rasmussen observed that Victim 1 had foam coming out of his mouth and abrasions to his left knuckles and wrist. Also, some abrasions to his right knuckles. Victim 1 did not have any shoes on nor possessions on him.

SRO Rasmussen is familiar with Victim 1 from past professional contacts. And he is a known past drug user. SRO Rasmussen made contact with Victim 1's parents and they said that Victim 1 left the residence on 4/6/23 around 6:30 PM and never returned home.

On 4/ 7/ 2023, SRO Rasmussen requested a ping on Victim 1's cell phone and Verizon indicated that the phone was turned off at 8:02 PM on 4/ 6/ 2023. Verizon indicated that the last tower the phone pinged was at 1107 Dartford Rd, City of Ripon. The signal from the northeast side of the tower was approximately 1.65 miles distance. 554 Scott Street, City of Ripon, per Google Maps measures approximately 1.56 miles from the same tower used for the ping.

Ripon Police Department obtained video footage from 2 churches in the area of Houston Street and Blossom Street which showed Victim 1 walking northbound on Houston Street at 7:05 PM on 4/ 6/ 2023, with 2 other individuals, which were later identified as Maison Springston and Joseph Schmidt-Rehbein (Joey).

On 4/ 7/ 2023, SRO Michels and SRO Rasmussen made contact with Maison and he told them that he saw Victim 1 on 4/ 6/ 2023 at Selfridge Park in Ripon Wisconsin. He said he had seen Victim 1 between 4:30 and 5:00 PM and that after being at the park Victim 1 left alone northbound on Water Street.

On 4/ 10/ 2023., SRO Michels and Sergeant Borkenhagen talked with Maison, and he said that Victim 1 told him he needed to make a run so Maison and Joey went with him. Maison at first said that they went to Jackson Street into a house there. Later he reported that they went north on Houston Street, and then east on Scott Street. Maison stated that they paused by a house on Scott Street but continued walking eastbound. They continued north on Stanton Street and turned West on East Jackson Street. Maison said he thought they were going to stop at a house closer to Stanton Street but continued westbound and stopped at 433 East Jackson Street. Maison stated that Victim 1 went into the garage of the residence. After some time, Maison and Joey decided that they didn't want to be any part of that and walked the railroad tracks South from that location. And ultimately to Maison's house on 1209 Metomen Street.

On 4/11/2023, SRO Michels spoke to Joey, and he reported that he last saw Victim 1 on 4/ 6/ 2023. He said they, Joey and Maison, were walking on foot northbound on Metomen Street and Victim 1 was walking southbound on Metomen Street. They met up and went to the skate park also known as Selfridge Park. Joey reports that they were at the park for a bit and then Victim 1 stated that he had to do something. So, Joey and Maison decided they would go with him. On the video footage, Joey and Maison are in front of. Victim 1 and Maison is wearing a backpack. Joey stated that they traveled northbound on Houston Street. And then eastbound on Scott Street. He said that Victim 1 was trailing behind them the entire time. Joey said that he and Maison stopped in front of the church on Scott Street, to wait for Victim 1. Joey stated that Victim 1 caught up and they continued walking eastbound on Scott Street. Joey reports that he and Maison got to the railroad tracks and decided since Victim 1 was lagging behind so much, they would just take the tracks. They walked southbound on the tracks to Sandmar Street and then walked to Maison's house. Joey described Victim 1 as being fucked up and said that he has never seen Victim 1 messed up before.

On 4/10/2023, SRO Michels and Sergeant. Borkenhagen spoke with Witness 1. Witness 1 reported that he was with Victim 1 on 4/ 6/ 2023, at the skate park. He reported that Maison and Joey were also there. He reported that Victim 1 looked like a zombie but talked normal. Witness 1 stated that Victim 1, Maison, and Joey were talking about going to hang out at Mike and Olivia's house. SRO Rasmussen knows from past professional contacts and calls that Ripon Police Department has responded to that address and Olivia Nordvold lives with Michael Manske at 554 Scott Street, Ripon.

On 4/11/2023, Sergeant Borkenhagen talked with Michael Manske over the phone at approximately 3:50 PM. Manske told Sergeant Borkenhagen that on 4/ 6/ 2023, between 8:00 PM and 9:00 PM, Maison, Victim 1, and Joey came over to his house. Maison came into the house to drop off a vape juice cartridge while Victim 1 and Joey waited outside. Victim 1, Maison and Joey left the property last seen heading West on Scott Street. As previously noted, Victim 1's phone, per Verizon, was turned off at 8:02 PM on 4/ 6/ 2023.

On 4/ 11/ 2023, at approximately 4:35 PM, Officer Watry of the City of Ripon Police Department was notified by Fond du Lac County dispatch of a citizen assist. They advised that a counselor from MPTC would like to speak to an officer. The counselor was identified as Witness 2. Witness 2 stated that she had a meeting with Olivia Nordvold around 10:00 AM earlier in the day. Olivia had some information that she shared with the counselor regarding the death of an 18-year-old, victim 1. Witness 2 reported to officer Watry that Olivia told her that she lives at 554 Scott Street with her 21-year-old boyfriend identified as Michael Manske. Olivia stated that in the late night 4/ 6/ 2023, or the early morning of 4/7/2023, that Victim 1 had come over to their house with an unnamed 15-year-old male. While inside the residence at 554 Scott Street, Olivia stated that the 15-Year-old had sold Victim 1 some pills believed to be Percocet.

Witness 2 reported that Olivia told her that Victim 1 then took the pills, crushed them, and snorted them inside the residence. Soon after he did this, Olivia stated that Victim 1's face started to turn white, his lips turned blue, and he started to have seizures. She stated that it was obvious that he was overdosing because of the pills he just took. Witness 2 said that Olivia advised that Manske then yelled to get Victim 1 out of his house since he did not want him overdosing while inside the residence. It was at that time that the 15-year-old grabbed Victim 1 and escorted him outside. Olivia told witness 2 that Victim 1 was alive when he was escorted outside, and she last saw him near the sidewalk. Olivia's statement directly contradicts Maison and Joseph's statements that they had only been with Victim 1 for a short time.

On 4/11/ 2023, SRO Rasmussen and other officers of the Ripon Police Department served a search warrant on 554 Scott Street in the city of Ripon. This was the home of Olivia Nordvold and Michael Manske. The following items of importance were located:

4 paper plates containing a green leafy substance believed to be raw marijuana weighing one gram were located in a TV stand in the living room,

6 plastic bags with a green leafy substance in them. One bag had 3 grams of green leafy substance.  
A pink metal container with green leafy residue,  
A blue white pulse oximeter.  
A blue spec believed to be from a Percocet pill.  
3 Multicolored rubber containers. 2 containers Held wax like substance is believed to be THC weighing 2 grams.  
Items tested positive for THC.

During the warrant, SRO Michels spoke with Olivia. Olivia stated that victim 1, Maison, and Joey came to her house. While at the house, Joey removed pill from his wallet, which Olivia believed to be Percocet, gave them to victim 1, and he, Maison, and Victim 1 snorted the drug through a rolled-up dollar bill. Olivia told Michels after Victim 1 did this, he started nodding off, and then his lips started turning blue and he started going unconscious. Olivia reported that they had a pulse oximeter, that they put on Victim 1's finger and observed his pulse went from 115 to 41.

During the warrant, Officer Watry spoke with Michael Manske, and he said that once Victim 1 started overdosing he told Maison and Joey to get him out of his house. Olivia said that Joey put Victim 1 over his shoulder and walked out the West door of the residence.

On 4/13/ 2023, SRO Michels met with Joey while in a recorded interview room, where Michels' interviewed Joey. Joey was able to accurately understand the term for nodding off and believed this to be what Victim 1 was doing while at 554 Scott Street. Joey admitted that he and Maison left Victim 1 lying on the ground and that he ran away.

On 4/13/23, officers of the Ripon Police Department subsequently executed a search warrant on Joey 's residence, located at N7091 Pollock Road, Township of Metomen, Fond du Lac County Wisconsin.

On 4/ 13/ 2023, during the search warrant of Joey 's residence, officers located items of drug paraphernalia, 10 individually packaged zip lock bags containing suspected marijuana that tested positive for THC, varying in weights of 6.6 grams, 40.5 grams, 78.5 grams, 32.5 grams, 47.5 grams, 20.5 grams, 28.5 grams, 32.5 grams, 29 grams, and 24.5 grams, for a total of 340.6 grams and other varieties of THC products.

Search warrants for the contents of phones belonging to Olivia Nordvold, Michael Manske, Joseph Schmidt-Rehbein, and Maison Springston were obtained and executed. DCI forensically downloaded the contents of the phones onto 2 thumb drives that were now labeled as evidence item number 94. SRO Rasmussen was able to review the contents of phones for Joey and Maison and gathered additional evidence indicating their involvement in the buying and selling of illegal drugs.

SRO Rasmussen observed activity displayed in Joey 's telegram account, which is under his username, "drippinplug". SRO Rasmussen knows through his training and experience that telegram is a social media platform commonly used by those who buy and sell illegal items or services, including drugs. SRO Rasmussen was able to see several threads where Joey is messaging others about buying and selling drugs. The thread that was most pertinent was the thread with victim 1. In the conversation between Joey and Victim 1, on 4/5/23 and 4/6/23, Joey told Victim 1 that he could get him some drugs and that the drugs contained Fentanyl. They discussed price and when Joey will be getting them. On 4/6/23, at 6:23 pm., Joey says he is at Maison's, he has the pill's and he and Maison, and Victim 1 are walking toward each other so they can meet and make the deal. Victim 1's message at 6:25 pm, was confirming that Joey wanted him to walk down Metomen to meet Joey.

SRO Rasmussen was able to review the GPS coordinates for Joey 's phone related to April 5-7, 2023. Based on Joey's conversation with victim 1, the 5th of April appears to be the date where Joey is going to pick up the pills. Joey's phone travels from the Ripon high school to Maison 's residence at 1209 Metomen Street and arrives at Maison's at roughly 3:17 pm. Joey's phone location shows that he was only there for a few minutes and is



observed traveling northbound on Metomen Street by 3:22 PM. By 3:30 PM, Joey's phone was now traveling northeast on State Highway 44 out of Ripon. By 3:52 PM, Joey 's phone is now traveling northbound on I-41, where it continues until exiting at West Bell Street, Neenah Wisconsin at 4:00 PM and begins traveling eastbound. Joey 's phone then shows as being at an apartment complex, determined as being the Southview Park apartments from 4:33 PM until 5:04 PM. And more specifically inside of the west side of the most southern apartment building, 122 Bell St. By 5:05 PM, Joey 's phone is returning westbound on West Bell Street towards I-41. By 5:19 PM, Joey 's phone has traveled southbound on I-41 and exited and is traveling southwest on Highway 44. Joey's phone continues traveling on highway 44 until returning to Ripon at 5:35 PM. By 5:40 PM, Joey's phone is southbound on Metomen Street and returns to Maison's address by 5:41 PM where it remains until 6:31 PM.

SRO Rasmussen also noted that while reviewing Maison 's phone, Maison had an Internet search for what's in a perc 30 and perc 30 at approximately 6:16 PM on April 5th, 2023. This would have been at the same time that Joey 's phone showed as being at Maison's home after returning from Neenah.

On 4/ 6/ 2023, at approximately 6:30 PM, Joey's phone is shown leaving Maison's house and to be moving northbound on Metomen Street. By 6:40 PM, Joey's phone is shown as being on Metomen Street, just north of Belleville Street. By 6:45 PM, Joey 's phone is on to Houston Street, just north of east Fond du Lac Street, going towards Selfridge Park. By 6:50 PM, Joey 's phone is in the area of Selfridge Park. At 7:05 PM, Joey 's phone is now moving north and west from Selfridge Park, back onto Houston Street. As previously noted, this is where the group of Joey, Maison and Victim 1 are observed on surveillance footage. By 7:07 PM, Joey's phone is eastbound on Scott Street, traveling toward 554 Scott Street. At approximately 7:10 PM, Joey 's phone arrives at 554 Scott Street, where it remains until 7:55 PM, where Joey 's phone takes a path going east away from the residence. This is the direction in which Victim 1's deceased body was located. It should be noted that Victim 1's phone was turned off or went dead at approximately 8:02 PM.

At 7:56 PM, Joey 's phone is now southeast of the residence which would be a large yard between the Silver Creek and the intersection/corner of Scott Street and Stanton Street. By 7:57 PM, Joey 's phone has crossed over the Silver Creek and is continuing southbound into the area of the cobblestone estates, 588 Fenton Street. SRO Rasmussen personally walked both the northern and southern sides of the Creek and knows that this is not an easy task to accomplish without ending up in muddy water, as it begins to turn into forestry and the terrain is not easy to navigate across. By 8:07 PM, Joey 's phone is back to East Fond du Lac Street and heading southbound to Saint Wenceslas Street. By 8:12 PM, Joey's phone is in the parking lot of Ripon high/ middle schools, continuing to travel southbound. At 8:11 PM, Joey makes a phone call to his girlfriend. In addition to the phone call, Joey and Maison were observed on school security cameras walking through the parking lot of the Ripon high/ middle schools, which confirms Joey had his phone on his person.

On 4/ 14/ 2023, officers interviewed Witness 3, who is the girlfriend of Maison Springston. During the interview, she tells police that she had information Maison personally told her pertaining to Victim 1's death. Witness 3 stated that Maison told her on 4/ 6/ 2023 that he and Joey went to sell Victim 1 a "perc 30". Maison told her that Maison,Joey and Victim 1 went to a 21-year-old 's house. Witness 3 said Maison told her that Victim 1 was already on liquid Molly and heroin prior to meeting them that evening. She said Joey only had one pill on him which he sold to Victim 1 at the 21-year-old 's house. Maison said that victim 1 crushed up the entire pill and snorted it. After Victim 1 snorted the pill, he began to overdose and eventually died while still inside the house. Maison told her that Michael Manske wanted Victim 1 out of the house as soon as he overdosed. She said the three of them (21-year-old, Maison and Joey), carried Victim 1's body outside and put him on the sidewalk.

She said that Maison picked her up in the morning on 4/7/23 and brought her back to his house. Maison told Witness 3 that "Victim 1 was dead" and that they sold him the perc. Maison said that they had taken victim 1's money and drugs and thrown them in the creek. Witness 3 stated that Joseph and Maison got the drugs from a person named Kyle in Neenah. There was one constant name observed in Snapchat labeled as Kyle for both

Joey and Maison. Kyle's user handle was. "lilhashtronaut". There was another Kyle observed on Maison's Snapchat that had the user handle "lilhashtronaut420". In Joseph 's phone, Kyle was labeled as Kyle with an outlet plug-in emoji at the end, which the officer, based on his training and experience, states is an emoji commonly used in drug lingo the person being their "plug" or drug supplier.

SRO Rasmussen was also able to review jail calls for Maison and Joey. In a phone call with his uncle, Joseph talked about the drugs coming from Neenah. SRO Rasmussen was also aware through prior contacts and arrests of an individual named Kyle Lamb. Kyle Lamb had previously lived in Ripon but had since moved to Neenah. SRO Rasmussen was able to confirm through open cases that Kyle Lamb's address in April 2023, was 122 West Bell Street, number 2, Neenah, Wisconsin. SRO Rasmussen was able to determine that Kyle Lamb had been arrested in April of 2023, in Winnebago County, for charges of possession with intent THC, maintaining a drug trafficking place, and felony bail jumping. Rasmussen followed up with the Neenah Police Department and learned that this was in reference to an incident they responded to at Kyle's address 122 West Bell Street number 2, Neenah Wisconsin for a shooting during a drug deal gone wrong. That case resulted in several search warrants being executed. During this process, a pink apple phone, belonging to Lamb, was confiscated. Neenah PD was able to locate a telegram account for Lamb, which he utilized to communicate for drug transactions and had a user handle of "lilhashtronaut". This was the same user handle for "Kyle" on Joey and Maison's snapchat accounts.

Rasmussen was aware that Kyle Lamb had ties to the Ripon area and had received an anonymous tip that a "Kyle from Neenah" was selling drugs to juveniles in the Ripon area. Witness 4 stated that a "Kyle from Neenah" was the dealer supplying Joey and Maison. Joey's phone call with his uncle said he was getting his drugs in Neenah. The Winnebago County arrest of Kyle Lamb for drug trafficking from the address of 122 West Bell St., in Neenah was the exact building Joey's phone was tracked to on April 5th, 2023. All of the above indicate that Kyle Lamb is the supplier of drugs to Joey and Maison.

Investigation has shown that Maison was with Joey and Victim 1 on the night of April 6th. Maison made a statement at the time of his arrest implicating that he was the person that sold Victim 1 the pill. Joey 's phone is observed as being at Maison's residence just before traveling to Neenah and then back to Maison's residence immediately after going to Neenah on April 5th, which is when the deal is believed to have taken place for them to be supplied with the Percocet pills. Maison 's internet search for Perc 30s was made on April 5th, 2023, just after Joey 's phone shows as returning from Neenah and while it was at Maison's residence.

While reviewing Lamb's telegram account, Rasmussen came across a thread of messages that were either typed, audio chats, or video chat sent between Lamb and the telegram user Donavyn Mueller. Mueller was the individual involved in the shooting at Lamb's residence. The messaging between Lamb and Mueller, which Rasmussen observed dated back to March 17th, 2023, had a total of 662 messages exchanged. Those messages sparked an over month-long string of communication between Lamb and Mueller, regarding their illegal drug sale business, as well as discussions of illegal firearms and firearm accessories.

Some of the audio and video messages exchanged between Lamb and Mueller, stood out in regard to their significance. On March 20, 2023, at 9:47 PM, Mueller sends Lamb an audio message where he is informing Lamb of what the pills he would be selling him really are, and what their potency is. Mueller tells Lamb the product is definitely good, that it's good money, but it's not good for your clientele. Mueller tells Lamb that there is fentanyl in the pills, and that if someone takes a full pill or a small person takes more than half of one, it would really mess them up. This message clearly shows that Mueller was knowingly distributing fentanyl laced counterfeit pills with the appearance of being Percocet 30 milligram pills.

The messages show that on 4/5/23, at approximately 9:08 am, Mueller delivers the drugs to Lamb. Lamb then delivers to Joey, Joey then returns to Maison's house. Joey and Maison then deliver to Victim 1 on the 6<sup>th</sup>.

Rasmussen was also able to obtain a search warrant for Mueller 's phone. While reviewing Mueller's phone, the same message thread between Lamb and Mueller was observed. In addition to this, Rasmussen observed Mueller 's phone was full of drug and gun deals, as well as gun accessories like switches which convert a semi-automatic firearm into a fully automatic.

Rasmussen also noted that Mueller was reviewing and had screenshot pictures in Google searches of powders that could be used as cutting agents for drugs, powders that were designed to aid in molding of pills and appear to have been researching ways to press pills and had online shopping screenshots showing. Pill press moldings. Rasmussen observed other messages with Mueller and other drug dealers where trades were made for drugs. Mueller was both offering to buy and sell firearms to and from various individuals. Mueller had numerous photos and videos of different guns as well as illegal switches. Rasmussen was able to confirm that these were original photos and videos based on the hand tattoos that Mueller has on back of his hands with one saying loyalty and the other saying self-made which indicate that Mueller was actually in possession of these items.

Adam Covach, M.D., the Chief Medical Examiner for Fond du Lac County performed an Autopsy on Victim 1, on April 7, 2023. The Medical Examiner listed Bromazepam and Fentanyl toxicity as the cause of death and the manner of death as accidental.

Based on the foregoing, the complainant believes this complaint to be true and correct.
