Complainant, Hannah N Schuchart, an Assistant District Attorney, being first duly sworn on oath, deposes and says that:

Count 1: BAIL JUMPING

The above-named defendant on or about Monday, July 1, 2019, in the City of Green Bay, Brown County, Wisconsin, having been charged with a misdemeanor in Brown County case number 2019CM238 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of her bond, contrary to sec. 946.49(1)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 2: BAIL JUMPING

The above-named defendant on or about Thursday, October 17, 2019, in the City of Green Bay, Brown County, Wisconsin, having been charged with a misdemeanor in Brown County case number 2019CM238 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of her bond, contrary to sec. 946.49(1)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 3: RESISTING AN OFFICER

The above-named defendant on or about Wednesday, March 24, 2021, in the Town of New Denmark, Brown County, Wisconsin, did knowingly resist an officer, while such officer was doing an act in an official capacity and with lawful authority,, contrary to sec. 946.41(1) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 4: BAIL JUMPING

The above-named defendant on or about Wednesday, March 24, 2021, in the Town of New Denmark, Brown County, Wisconsin, having been charged with a misdemeanor in Brown County case number 2019CM238 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of her bond, contrary to sec. 946.49(1)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Complainant is an Assistant/Deputy District Attorney with the Brown County District Attorney's Office and knows of the above offense(s) on information and belief based upon:

PROBABLE CAUSE:

The complainant, being duly sworn on oath, swears that he/she has had the opportunity to review the police reports from Sergeant Patenaude of the Brown County Sheriff's Department, and other documents supporting this complaint referenced herein, which are the types of reports and documents kept in the ordinary course of business, which complainant believes to be truthful and reliable because they have proven to be truthful and reliable on numerous occasions in the past.

The complainant further asserts that based upon his/her review of the referenced reports and/or supporting documents, the incidents alleged occurred in the Town of Denmark, Brown County, Wisconsin.

1. The report of Sqt. Patenaude, which indicates that:

On Wednesday, March 24, 2021 I, SGT Joseph Patenaude #276, was on duty for the Brown County Sheriff's Office in full uniform and assigned as the afternoon shift East Patrol Sergeant. At about 7:01 PM the Brown County Communications Center (BCCC) received a call for a welfare check at S CTH P (Town of New Denmark, Brown County, WI). The caller advised BCCC that her neighbor had been knocking at her door a few minutes ago stating that she doesn't have any food and is being denied food and that her family is lost. The caller did not know the neighbors name but provided the address of 5537 S CTH P.

After reviewing the call I was aware of previous contact attempts at the given address and was aware that the female who lived there was uncooperative with officers to the point of barricading her door. I remembered the females name to be Lisa and after I reviewed some of the previous calls I found her full name of **Lisa M Kraszewski DOB: 06/28/82.** Lisa had previously had a warrant so I requested BCCC to complete a records check and was advised the warrant was still active. The warrant was a body only misdemeanor Bench Warrant for multiple counts of animal mistreatment offenses, child neglect and resisting an officer.

Deputy S Thor #241, Deputy J Mueller #1392 and I responded to the address to attempt the requested welfare check. On arrival we approached the residence and I saw there was lights on inside. I approached the front door and before knocking I saw a female, who I recognized as Lisa from my previous contacts, sitting on a living room couch. I did not see any animals and the house seemed to be cluttered but organized. I knocked on the door and as Lisa came to answer I turned my flash light on so she could see it was sheriff's deputies. Lisa opened the

inner door, leaving the screen door closed, and began talking about how she was being denied food from the pantry and the bank wouldn't give her any money. Lisa would interrupt one sentence topic with another that had no relation to the other. Lisa talked about how her family was taken away and that officers had raped her during previous interactions and she reported it to the local veterinarian office.

I asked Lisa if she wanted to step outside or if I could come inside to discuss the matter further and she took a step back from the door. I opened the screen door and Lisa turned around and started to walk away from me saying she needed to protect herself. I was concerned that Lisa may be attempting to obtain a weapon as she was walking toward the couch she had been seated on and the doorway to the kitchen. I reached out and grabbed Lisa's right wrist and she immediately turned around, tried to push me back and then pull her hand away. I was able to maintain control of her wrist and told her that she was under arrest for the active warrant. Lisa continued to violently push and pull her arm away from me and Deputies Thor and Mueller stepped into to assist. Deputies were unable to get Lisa to comply with our orders to stop resisting and place her hands behind her back. Lisa twisted her body and pushed and pulled with both of her arms. I advised Deputy Thor and Deputy Mueller to take Lisa down to the floor in attempt to gain better control of her. Deputies were able to lower Lisa to the floor in a controlled manner. Lisa continued to move her body around and kick at deputies. Deputy Thor had control of Lisa's right arm as well so I advised him I was going to move to control her legs. I was able to pin Lisa's legs down and then hold her right elbow while Deputy Thor secured her right wrist in a handcuff.

I notified BCCC that Lisa was in custody but uncooperative and requested they confirm the warrant. I also requested two additional deputies to respond and Deputy Z Walters #1354 and Deputy R Mejia #1393 were dispatched. Because of her positioning we were not able to get her left arm around to her back so we readjusted and pulled Lisa into a more open space where we were able to keep her lying flat on her stomach and got her left arm back and secured in handcuffs.

Once Lisa was secured in handcuffs Deputy Thor was able to maintain control of her legs and hands while Deputy Mueller maintained control of her upper body and monitored her breathing. I retrieved the WRAP restraint system from my squad and Lisa was secured in the WRAP to keep her from harming herself or deputies. Deputies continued to monitor Lisa and I advised BCCC that Lisa was in the WRAP and other units could slow down their response but keep coming. Once Deputies Walters and Mejia arrived we made a plan to carry Lisa out to Deputy Mueller's squad car. Deputies carried Lisa out using the handles on the WRAP and monitored her condition while moving her. From the time I first secured her wrist until Lisa was in the squad she was screaming that deputies were raping her and violating her rights. Lisa actively resisted deputies attempt to take her into custody throughout our contact.

Deputy Mueller then transported Lisa to the Brown County Jail (BCJ) with Deputy Thor and I following. Lisa was removed from the squad by BCJ staff. While BCJ staff were speaking with her, Lisa made a vague statement about wanting to harm herself. BCJ staff removed Lisa from the WRAP and secured her in a restraint chair as she continued to be uncooperative. BCJ staff then contacted the Crisis Center who attempted an evaluation over the phone. Lisa would not answer the questions being asked of her and would speak over the counselor. Lisa demanded to speak with the President. At one point Lisa stated that if she would have known what was going to happen she would have killed officers when they showed up at her house. I spoke

with the counselor and advised her on the contact today and history with Lisa. It was determined that Lisa would be safe to be monitored by BCJ staff.

2. The records of the Brown County Clerk of Courts as maintained on CCAP Circuit Court Access page, which indicate that in Brown County case number 2019CM238, this defendant is charged with 7 counts of mistreating animals, 10 counts of providing improper animal shelter-sanitation standards, 2 counts of child neglect, and resisting an officer, all misdemeanors. The defendant appeared before a court commissioner in the Brown County Courthouse, located at 100 South Jefferson Street, in the City of Green Bay, Brown County, Wisconsin, on or about February 22, 2019 and bond was set in the amount of a \$10,000 signature bond with conditions that the defendant commit no crimes or new law violations and that she make all future court appearances. The defendant signed this bond and was released from custody subject to its conditions.

After further scheduling, the defendant was ordered to appear before the Honorable John P. Zakowski in Branch 6 of the Brown County Circuit Court located at 100 South Jefferson Street, in the City of Green Bay, Brown County, Wisconsin, on July 1, 2019. On July 1, 2019, the defendant failed to appear as ordered.

After further scheduling, the defendant was ordered to appear before the Honorable John P. Zakowski in Branch 6 of the Brown County Circuit Court located at 100 South Jefferson Street, in the City of Green Bay, Brown County, Wisconsin, on October 17, 2019. On October 17, 2019, the defendant failed to appear as ordered.

On July 1, 2019, October 17, 2019, and March 24, 2021, the bond in 2019CM238 and all concomitant conditions were in full force and effect.

Based on the foregoing, the complainant believes this complaint to be true and correct.
