CRIMINAL COMPLAINT

For Official Use

Complainant, a Special Prosecutor, being first duly sworn on oath, deposes and says that:

Count 1: SUBSTANTIAL BATTERY, DOMESTIC ABUSE

The above-named defendant on or about Sunday, September 26, 2021, in the City of Green Bay, Brown County, Wisconsin, did cause substantial bodily harm to A.A.J., by an act done with intent to cause bodily harm to that person, contrary to sec. 940.19(2), 968.075(1)(a) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

And further, invoking the provisions of sec. 968.075(1)(a) Wis. Stats., because this charge is an act of domestic abuse, costs upon conviction would include the domestic abuse assessment imposed under sec. 973.055(1) Wis. Stats.

Count 2: DISORDERLY CONDUCT, DOMESTIC ABUSE

The above-named defendant on or about Sunday, September 26, 2021, in the City of Green Bay, Brown County, Wisconsin, while in a public or private place, did engage in abusive, boisterous, indecent, profane, unreasonably loud, violent or otherwise disorderly conduct, under circumstances in which such conduct tended to cause or provoke a disturbance, contrary to sec. 947.01(1), 968.075(1)(a) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

And further, invoking the provisions of sec. 968.075(1)(a) Wis. Stats., because this charge is an act of domestic abuse, costs upon conviction would include the domestic abuse assessment imposed under sec. 973.055(1) Wis. Stats.

Complainant is a Special Prosecutor with the Brown County District Attorney's Office and knows of the above offense(s) on information and belief based upon:

PROBABLE CAUSE:

The complainant, being duly sworn on oath, swears that she has had the opportunity to review the police reports from officers of the Green Bay Police Department, and other documents supporting this complaint referenced herein, which are the types of reports and documents kept in the ordinary course of business, which complainant believes to be truthful and reliable because they have proven to be truthful and reliable on numerous occasions in the past.

The complainant further asserts that based upon her review of the referenced reports and/or supporting documents, the incidents alleged occurred in the City of Green Bay, Brown County, Wisconsin.

1. Your complainant's review of the reports of Officer Ethan Plonke of the Green Bay Police Department, which state:

On Sunday, September 26, 2021, I, Officer Plonke was working full uniform patrol in a marked squad car as unit 4A2 for the City of Green Bay when I added myself to a call at 5** Fifth Street in Green Bay, Brown County, Wisconsin, for the report of a male/female physical disturbance in which the male subject was picking the female up and throwing her around the house. I was familiar with the name of the male subject, and I was also familiar with that male being a physically large individual, so I added myself to the call.

Upon arrival, other officers and I could hear a male yelling in the house. Other officers and I attempted contact at the front door and while we were about to knock, the male subject slammed the front door. The male subject was identified as Letroy S Guion, DOB: 06/21/1987. Letroy was verbally escorted out to the front porch. Letroy initially stated no one else was in the house with him and he was ranting to himself and yelling in his own house. Letroy denied officers entry to the residence. While speaking with Letroy, other officers went and spoke with the complainant, who stated she had seen Letroy throw the female, later identified as A.J. With this information from the complainant physically seeing Letroy physically throwing A.J. around the house, officers informed Letroy we would be making entrance into the residence. Letroy stepped down from the porch and two officers went inside the residence to clear the residence and make sure there was no one else inside. As officers were in the residence, they found A.J. in an upstairs bedroom, intoxicated, and incoherent due to her injuries sustained from Letroy physically assaulting her. I assisted Officer Dimitrov in taking Letroy into custody and escorted him to Officer Dimitrov's squad car.

After placing Letroy into the squad car, I spoke with female complainant, identified as K.D. I spoke with K.D. and asked if she would be willing to give a written statement to what she had seen tonight. She stated "yes" she would give a statement. K.D. stated that around 2:30am, she heard her dogs barking, which woke her up. As she woke up, K.D. heard the male next door screaming at the top of his lungs. K.D. went outside to smoke a cigarette after being woken up, and when she went outside on her front porch the neighbors had gotten quiet, so she went back to bed. Sometime later, K.D. stated her dogs started barking again and she heard the male yelling stuff like "you always do this", "you always act like this". After the male

stated this, she heard the female state something back and the male responded back yelling "you made me do this, you hit me with the door, you provoked me". K.D. stated she could hear what she thought sounded like things being thrown around the house, the male/female had their windows open on the upper level of the house and K.D. could see the male digging around things, picking them up, and throwing them around. The male appeared to be very sweaty and angry, and she knows A.J. and the male who live there. K.D. stated while Letroy was yelling at A.J., she saw Letroy pick up A.J. over his shoulders and throw her somewhere in the bedroom upstairs. After seeing this, she decided to call 911 because she was worried about A.J.'s safety. While she was on the phone with dispatch, K.D. stated she heard Letroy yelling at A.J. "you broke me ?????". K.D. stayed on the phone with dispatch and then she noticed the police arrive, which was the same time she saw the lights go off in the house. K.D. believes Letroy and A.J. have two kids together and they both live at 5** Fifth Street. I typed the written statement and printed it for K.D. to read. K.D. agreed it was accurate to what she had told me, and she signed the statement. Later, during my shift, I scanned the statement into the case.

2. Your complainant's review of the reports of Officer Blagov Dimitrov of the Green Bay Police Department, which state:

On September 26, 2021, I, Officer Dimitrov, was working in full uniform patrol in the City of Green Bay as unit #4B1. At approximately 04:56 hours, I had been dispatched to 5** Fifth Street for the report of a male/female physical disturbance. The complainant stated she could hear this happening from her window into their bedroom window. This had been going on for about two hours. The complainant stated the male picked up a female and threw her and kept screaming "get your ass up". The complainant stated the male was yelling "you hit me with a door, and now you make me kick your ass". The female was identified as A.J. The male was identified as Letroy S Guion, DOB: 06/21/1987.

Upon arrival, while walking up to the house, I heard a very loud and sharp yelling from a male at someone or something from the inside of 5** Fifth Street. The yelling sounded as if someone was very angry, yelling at the top of their lungs, consisting of lots of swearing. I checked the back yard of this residence to assure there was no one currently in the back yard. I met up with other officers in the front yard where we could hear further yelling. We had made the decision we needed to make contact or entry to the residence due to the report of a female being beaten up and thrown around inside the residence. While I was walking to the front door to knock on the door, Letroy had slammed the front door hard enough to startle officers on scene. I retreated to the front yard off the porch due to this. Letroy answered the door. Other officers drew their tasers, and I drew my firearm due to not knowing what Letroy's intentions were going to be after slamming his hand on the front door and then swinging the door open. After drawing down on Letroy with my firearm, and other officers with their tasers, we had instructed Letroy to come outside with his hands up. Letroy was very hesitant to come outside. Eventually we were able to talk him out of his house. Once we were able to see he had no weapons on his person, I holstered my department issued firearm. Officers advised Letroy we were dispatched to his house because of a report of a disturbance. While attempting to explain this to him, Letroy became very verbal and angry with officers, and became more agitated once officers advised Letroy we needed to check inside to make sure no one was hurt. Initially, Letroy stated he was the only one home and was yelling at himself because he gets angry. Officers on scene continued to speak with Letroy to convince him to step off the

porch so we could check the inside of the house due to believing there was someone injured inside. Sgt. Brester arrived on scene. Sgt. Brester later explained to Letroy why we were allowed to make entry into the house without a search warrant due to Letroy constantly stating we needed a search warrant to enter his house. Letroy still did not want to listen or come off the porch. A few minutes later, after officers continued to speak with Letroy, Letroy did move off the porch. Once Letroy was off the porch, officers entered the residence to check for anyone injured inside. While officers were inside, Letroy stated his girlfriend was in there and they had gotten into an argument, and that she had thrown a door at him. It is unknown if he meant threw the door open, or if she had literally taken a door and threw it at him. Letroy stated he got angry at her. Letroy later admitted that she might be hurt. Officers inside advised the female located inside, later identified as A.J., had severe facial injuries and was not completely responsive. Officers inside requested for rescue to respond due to the female's injuries.

I placed Letroy in handcuffs. Letroy at this point was cooperative in being placed into handcuffs. I used two sets of handcuffs due to Letroy's body size, six foot four and three hundred twenty pounds. The handcuffs were checked for tightness and fit, and double locked. I escorted Letroy to my squad car where he was seated in the back seat of the squad car. It should be noted that Letroy had made a comment that "he just wishes he was dead". Letroy began crying while in the back seat of my squad. While he was crying, he stated "she hit me in the face with the door, and broke my god damn tooth and I lost it a little bit". I advised him I needed to read him his Miranda rights before I ask him any questions since he is in my custody. After reading him his Miranda rights, he stated he understood his rights. When I asked if he was willing to answer questions or make a statement, he stated "yeah, whatever". I tried to ask Letroy questions, but he would not answer any of the questions. He just remained in the back seat with his eyes closed and sniffing. While transporting Letroy to the Crisis Center due to his comments. He stated, "she had spazzed out on me tonight, and I blacked out, that's all". He started to talk about how she had cracked his tooth with the door. Letroy stated he had spit out pieces of his tooth out and he then lost it. He also stated they are both drunk and both had been drinking all night. I asked him if he needed to go to the hospital for his injuries and he stated "no". While en route to the Crisis Center, he started to make comments about how he played football, and he does not want to be seen as crazy and have mental problems because of all the football stuff. He stated he did not want any of this to be on the news. Letroy made a comment after being cleared from the Crisis Center that he is not a woman beater and that he blacks out when he is hit by women. He began to talk about how he doesn't hit women just to hit women, it happens when they provoke him. He stated, "when I black out, I am a fucking animal", "I'm a football player, I'm a fucking animal", "you bite an animal, you get bit back". He then stated all these NFL people don't want to admit that we took all these crashes to the head. Then he stated when people fuck with us, we snap the "fuck" out. He then stated they don't want to believe that "shit", that we just can't help it. We have a short fuse. He then made more comments about taking hits to the head while playing football and now having a short fuse. Letroy stated you just can't hit people like us in the face, that shit will just escalate really fast, and that's the truth. We arrived at the Brown County Jail, where I turned off my recording devices. It should be noted, while on the way to jail, he admitted they were both drunk, and that he had blacked out after she threw the door open, and the door hit his jaw and broke his tooth. He stated he blacked out and did not realize what he had done and did not know what happened. While en route to jail, Letroy made the comment "when I

black out, I'm a fucking animal". Due to these comments, I believed Letroy was admitting he did hit A.J. at some point during the disturbance.

It should be noted A.J. was transported to St. Vincent Hospital for her injuries. Officers were unable to gather a statement from her due to her being unconscious, or not alert enough to be able to make a statement. It should also be noted that Letroy is a former Green Bay Packer's player, has a very large body size and mostly muscle. It should be also noted that while at the residence, officers located a bag of green leafy substance on the dining room table. I had collected this and entered it into evidence as exhibit #753001. Throughout transporting Letroy to jail, he admitted he smokes marijuana every single day. I advised him that I would be giving him a citation for possession of marijuana. Letroy stated at jail that he had just gotten that yesterday and asked if I could leave it at the house. I advised him that I could not leave it at the house.

Letroy was jailed on charges of battery – substantial – felony; disorderly conduct – misdemeanor; both DVO related as both Letroy and A.J. are living in the same house and have a child in common based on what was explained to me by other officers on scene.

I went to the Green Bay Police Department and entered the green leafy substance, based on my training and experience, I believed to be marijuana. The green leafy substance was entered into evidence as:

- Exhibit #753001 – green leafy substance located on dining room table in a Ziploc baggy (#753002), testing positive for marijuana/THC.
- Exhibit #753002 – Ziploc baggy containing #753001.

3. Your complainant's review of the reports of Officer Brandon Eick of the Green Bay Police Department, which state:

On September 26, 2021, I, Officer Brandon Eick, was working for the Green Bay Police Department as 1F1. At 12:37 I informed dispatch that I would assist officers in a disturbance at 5** 5th Street, Green Bay WI. by getting a statement from the victim of the incident. Call notes stated that the victim, A.J., was at St. Vincent's Hospital.

When I arrived at St. Vincent's Hospital I made contact with the nurse working in room 412. I was advised that A.J. had a left intraorbital fracture along with hematoma injury to her eye. I then made contact with the Victim, and asked if she was willing to give a written statement. A.J. informed me that she would be willing to give a statement but did not remember anything from last night. After giving her statement, A.J. read over the statement and signed it as being true to her word. A.J.'s statement is summarized as follows. She does not remember anything from last night. A.J. stated that she has lived with Letroy Guion for the past five years and also has two children in common with him.

After getting A.J.'s statement I took photos of her injuries with my department issued phone and uploaded them to this case.

Golden House was provided A.J.'s information with her consent. The jail was also updated with her information.

Based on the foregoing, the complainant believes this complaint to be true and correct.
