I. Overall Content:

The purpose of this written report is to request mental health and wellness days for all staff members as a result of the stressors occurring this year. Note: This request is for this year only and not to be seen as a precedent for the future.

II. Board Motion Needed (if any)

A Board Motion is needed to approve the additional mental health days to be included in the 2021-2022 calendar.

III. Major Points in this Report:

The 2021-2022 District calendar contains the information listed below. The highlighted areas below include an explanation to utilizing two of the five and eight tenths days to provide mental health days to staff members.

- A. A committee of educators, administrators, and clerical staff worked on the development of the proposed calendar. The committee was represented by participation from all three school levels: elementary, middle, and high school.
- B. There are 190 professional staff days.
- C. There are 177 student contact days for all students. This also allows all District schools to exceed the hours of instruction required by the Department of Public Instruction.
- D. Five and eight-tenths banked inclement weather/snow/emergency days are built into the calendar as the District has enough instructional minutes at each level to allow for up to five and eight-tenths snow/emergency days. The proposal would retain two of those days for mental health and wellness days, which would allow for three and eight-tenths of snow/emergency days to remain.
- E. A virtual school day option will be implemented for high school students during the ACT testing that occurs for students in grade eleven. This will allow the District to maintain the five and eight-tenths inclement weather/snow/emergency days built into the recommended calendar.
- F. Fall parent-teacher conferences will be held so that every level has their own day. This will allow parents with multiple children to attend every level. By providing parents access to their students' information via Infinite Campus, spring conference attendance has drastically declined. The decision was made to have each building determine the best means by which to engage parents. "Conference time" will be thirteen (13) hours per building, outside of the school day. This could include "Get to Know You Conferences", Open House (all levels), STEM or Technology Night, etc. Parents may always make an appointment to discuss their child's progress with the teacher at any time throughout the school year.

- G. The start date for the Oshkosh Area School District occurs after September 1 as directed by law.
- H. There are nine early release dates to provide professional learning time.
- I. January 17, 2022 is a planned ½ day professional development and ½ day recordkeeping for staff members and a student non-instructional day for students. This will allow families to observe Martin Luther King, Jr. Day.
- J. February 17 and 18 will become a mental health and wellness break from the stressors occurring as a result of post COVID. Overwhelming feelings of stress and anxiety can cause people to feel exhausted, which leads to decreased productivity. For a one-year solution, the two mental health days would allow staff to decompress and recover from burnout. This is an incentive, similar to what businesses and universities across the country are offering. The strategy is to retain exceptional employees. If approved, communication will occur with staff, families, food service, daycare providers, UW-Oshkosh, and Kobussen.
- K. February 21 will remain as a professional development day for staff members and a student non-instructional day for students.
- L. Spring break returns back to the last full week in March and will take place from March 21-25, 2022.
- M. The calendar contains the ACT testing schedule for juniors in high school.
- N. The last day of school would be June 2, 2022, unless a fourth inclement weather day is needed. If this is needed, June 3, 2021 would become the last day of school.
- O. Graduation dates are scheduled for Friday, May 27, 2022 for Oshkosh West and Wednesday, June 1, 2022 for Oshkosh North, both being held at the Menominee Nation Arena. The dates will avoid potential athletic conflicts.
- P. A copy of the proposed District calendar is attached for your preview.
