Narrative

On September 13, 2020 at approximately 1319 hours I, Officer Snover, was dispatched to Martin Park for a report of suspicious activity. Sturgeon Bay City Alderman, David Hayes, reported individuals at the park with a tent, who were possibly campaigning without a permit. Hayes stated he didn't believe they had a permit and believed they should be removed from the park. I was informed that the individuals had a permit and were in contact with the City Parks Department and the City for approval to be utilizing the space at Martin Park.

I attempted to make phone contact with Hayes upon my arrival at Martin park, but there was no answer. I made contact with the individuals at the tent, identified as Amanda Jean DuQuaine and Molly Blahnik and Jennifer Quitko. Blahnik informed me she had been in contact with Chief Porter and City Hall regarding the petition signing booth they have set up for the "Recall of Governor Evers." I know Blahnik had been in contact with the police department regarding this event as it was shared in an e-mail from Chief Porter.

DuQuaine stated they had with Alderman Hayes was when he approached their tent and began to demand they didn't belong there and informed them he was a City of Sturgeon Bay Alderman. DuQuaine stated as Hayes began to walk away she mumbled, "Wow, what an asshole." Hayes quickly came charging back towards her and yelled at her, "You're a bitch! You want me to grab your pussy! Well that's what Trump would say." Jennifer Quitko and Molly Blahnik-Thronton stated they both witnessed this and found his words extremely offensive. Hayes informed them he would be contacting the police department and left.

I made contact with David Hayes on my second phone call attempt. I informed Hayes that the individuals paid the amount needed to rent the space at Martin Park as they all had informed me they did. Hayes was upset as they didn't provide a copy of the information he thought was required to rent the space and thought they needed a permit on top of the rental agreement. I asked Hayes to contact Chief Porter and City Hall on Monday to follow up with them for a copy of that permit. I was informed by Blahnik Thornton that she had been in contact with Chief Porter to be sure they were following all of the rules and laws when it came to setting up the petition signing.

At this time I was aware of the offensive behavior that Hayes created at Martin park. Because Hayes is the chairperson of the Democratic Part of Door County, and the petition signing was of an opposing view, it led me to believe this was just a verbal altercation regarding a difference of political opinions. Well after leaving the park, near the end of my shift, I was contacted by Jennifer Quitko, who wanted to let me know that DuQuaine and others were willing to give written statements as to the event that occurred and would like to proceed with charges against Hayes. I made contact with Quitko after my shift had ended and asked her to inform the others to write statements as to what occurred. Quitko was given my e-mail address and stated she would inform the others.

Statements will be added as they are received.

ADDITIONAL INFORMATION: AUDIO RECORDING OF DAVID HAYES:

On September 14, 2020 I, Officer Snover, received an e-mail with an attachment of audio recording from Door County Dispatch Center, of the call made by David Hayes on September 13, 2020. This information was added on September 15, 2020 as on September 14, 2020 I was on a special assignment for a different case. The audio clearly states Hayes saying, "Fuck, Can I grab your pussy, what else can I

do for you." "That's what Trump says, Trump says it all the time." Shortly after Hayes begins to talk with dispatch and inform them of his complaint. This recording has been added to the M-drive, saved to report file, 20-009710.

On September 15, 2020 I, Officer Snover, made contact with the following individuals at Martin Park, to obtain their statements as to the incident that occurred on Sunday, September 13, 2020.

The following written statements were sent to me by e-mail and copies will be attached to the report.

WRITTEN STATEMENT MOLLY BLAHNIK:

September 15, 2020 09:05

On Sunday, September 13, 2020 at approximately 13:15, I along with Amanda DuQuaine, Jennifer Lynn, (following identities unknown) Jennifer's father and his girlfriend and two male friends of DuQuaine were hosting an event to collect signatures to recall Governor Evers at Martin Park in Sturgeon Bay, Wisconsin.

Prior to the event, I personally notified the Sturgeon Bay Police Department of our intentions to host the signature collection, due to the political unease throughout the country. DuQuaine contacted the Sturgeon Bay Parks Department and spoke multiple times with an individual there to file the proper paperwork in order to "rent" the park for the collection event. According to DuQuaine, she filled out a sheet of paper, including the indication that a banner/sign would be posted at the park to inform passers-by of the event, and submitted \$60 of her own money for the application.

I arrived shortly after 12:00 to assist in the collection; DuQuaine and Lynn had been at the park since approximately 09:00. When I arrived, a small tent was set up with a folding table under it where both women sat with clipboards of papers to collect signatures. Prior to my arrival, the only displays were two American flags, one Thin Blue Line American flag, several 8 1/2" x 11" signs and another sign approximately 2'x2', the latter two both posted in the ground along the sidewalk on the northwest sidewalk of the park along Oregon Street. Upon my arrival I affixed a larger sign, approximately 2 ½ x 4', which I made that said "RECALL EVERS PETITION Sign Here Today!" All said "advertisement" indicated the recall effort against Governor Evers and in no way referenced the current presidential race or any other political affiliations. The only indication of any party affiliation on the scene was a Trump T-shirt worn by DuQuaine; all other attendees were in unadorned, "plain" clothes.

After a small break of citizens approaching our location and signing said petitions shortly before 13:15, a male approached us and identified himself as an Alderman for the city of Sturgeon Bay - he did not indicate his name. I later identified said Alderman by searching current Sturgeon Bay Alderman and recognized the individual as David Hayes. Standing directly in front of the collection table, Hayes was immediately confrontational with the group of seven individuals at the location. Hayes initially asked if we had a permit to be at Martin Park collecting signatures. I directed him to DuQuaine, since she was the one who was in contact with the Parks Department for the filing of the paperwork. He again asked DuQuaine if she had a permit to be in the park. DuQuaine responded with her efforts to obtain the permit by informing Hayes of the paperwork she filed, checking the box to indicate signs/banners would be placed and the payment of a fee for the application. Hayes became short with DuQuaine, stating for us to be in the park, we needed to physically have the permit for said application. DuQuaine indicated to Hayes that the Parks Department did not inform her of this necessity and that we did not have a physical copy of the paperwork. Hayes again indicated the need for a physical copy of the permit, at which point DuQuaine began to get frustrated. DuQuaine stated to Hayes "I don't know what to tell you" and that as taxpaying citizens, we had every right to be in a public park. Hayes started getting more agitated at that statement and began pointing at the signs posted along the sidewalk, informing us that we were allowed to simply walk around the park but could not have the "setup" we had. DuQuaine continued to indicate how she proceeded with an individual with the City Parks Department, clearly frustrated. At this point, no vulgar language was exchanged on either side.

When Hayes asked DuQuaine whom she spoke with, DuQuaine indicated that she wasn't surewhat the woman's name was, but that it may have started with the letter "S". Hayes scoffed at that remark, stating "Well, I'm not going to give you anyone's name". DuQuaine continued to assert that she was unsure of the individuals name and Hayes asked if it was 'Stephanie'. DuQuaine replied that she wasn't sure, but she did not believe her name was Stephanie. Throughout this point of the conversation, Hayes was also growing more agitated, shifting his stance and pacing in front of the collection table. He stated he did not wish to contact 'Stephanie' since it was Sunday, but that he did have her number in his phone and would do so if necessary. DuQuaine replied to that comment with a shoulder shrug, and passively indicated that he could do whatever he wanted and call whomever he wished including local law enforcement since they already knew what we were doing at the park. Hayes indicated that he would "do just that" and began to walk away from the table seemingly dialing a number on his cellphone and moving towards the North corner of the park. It was at that time that I contacted Officer Snover to forewarn her of the possible incoming call to dispatch from Hayes.

When Hayes was approximately 15-20 feet away from the table, DuQuaine looked at us individuals standing at the table and clearly, though not loudly, stated "Wow, what an asshole!" DuQuaine did not direct the comment towards Hayes specifically, but did say it loud enough for an individual within close vicinity to hear the comment. Hayes overheard the comment and immediately began walking back towards the table in a quick and aggressive manner. While doing so, Hayes' voice grew louder than the previous exchange and said "What did you just say? What did you just say?". When Hayes was within arms distance of DuQuaine, he leaned towards her, pointed his index finger in DuQuaine's face and called her a bitch. Hayes' physical demeanor was tense and aggressive, with fisted hands at his sides and shoulders leaned in towards DuQuaine, but he did not make any

sudden movements beyond that initial finger pointed at her face. DuQuaine replied to his comment with "Oh, I'm the bitch? You're an asshole!" It was at that point Hayes must have noticed DuQuaine's shirt, which had writing supporting President Trump on the front of it. Prior to this point of the altercation, DuQuaine was sitting at the picnic table directly alongside the tent with her hands and arms in front of her eating a sandwich. DuQuaine put the sandwich down in front of her when Hayes approached the second time. When Hayes saw her shirt, still within arms distance of DuQuaine and with his shoulders leaned in towards her, he loudly stated "You want me to grab your pussy too?" When Hayes stated this, he made a cupping and squeezing motion with his right hand, which he did not extend towards DuQuaine but left at his right side just in front of his body. At that time, Hayes had his cellphone up to his ear, still seemingly attempting to connect with a dispatcher. After Hayes made that last statement, one of the males in the group stood up from his seat at the picnic table and moved towards DuQuaine to assist her. Hayes backed up at this movement and situated himself directly in front of the collection table again. He looked at everyone else in the group and with a shrug of his shoulders stated something to the effect of 'What? That's what Trump says?' Several members at the collection table then began shouting at Hayes, saying things such as "Oh that's real fucking nice for a public official", "What's wrong with you" and other similar remarks.

Hayes then walked away from our group and no one followed him, all parties involved in the signature collection remained within the immediate vicinity of the tent. He moved toward the north side of the park while speaking on his cellphone. He then walked along the sidewalk on Oregon Street, still speaking on the phone and closely looking at the signs that we had posted along the street. After several minutes of doing that, he walked towards his small white SUV parked on 3rd Avenue on the north side of the park, entered his vehicle and drove off aggressively through the parking lot of the Healthy Way store, continuing eastbound on Oregon Street. Several minutes later Officer Snover arrived at the park. No further altercations ensued during the remaining time I was at the park until approximately 15:30.

WRITTEN STATEMENT AMANDA DUOUAINE:

September 15th, 2020

In early September, I, Amanda DuQuaine, contacted the City of Sturgeon Bay to inquire about holding an event at Martin Park in Sturgeon Bay. The contact information for the person I spoke with is below:

I do not recall the name of the woman I spoke with on the phone. I explained to her that I was interested in holding a public event at the park and I was wondering whether or not I needed to have it cleared with the city or not. I also explained to her that I know Martin Park is very popular and did not want to end up setting up on a day there was an event scheduled to be held in the location. She asked me what type of event I was planning to hold, to which I replied, "A recall Tony Evers signing event."

The woman at City Hall then suggested to me that I pay the rental fee for the park so that nobody else could hold an event on the same day as me. She directed me to go on the city website, print off the 2020 Park Reservation Form, and told me there was a fee of \$58.03 that would need to be sent in with the application. She then immediately booked my event to be held on September 9th, 2020. She let me know that there is a locked drop box outside of the building that houses municipality services offices and I could leave my application and fee in that lockbox outside of their office hours if need be. I printed the application that day and filled it out. I noticed a spot on the application that asked, "Do you need to place a banner in the park during your event?" I marked 'Yes' for this question on the application form. I did not know at the time if I was going to be using an actual banner but I was sure I would have some small signs. My father, Tim DuQuaine, wrote the check to the City of Sturgeon Bay for the park rental and I placed the application along with the check in the locked drop box that evening.

On September 8th, 2020, I noticed that the weather radar was showing rain for the day I scheduled the event. Being that it was a paper signing event, that was obviously an issue. I called the city once again and spoke with the same woman I spoke to the first time. I explained that the radar looked like rain and inquired about rescheduling my event for a different day. The woman on the phone asked me what day I was looking at, because on Saturday, September 12th, 2020, the Sunshine House had an event scheduled at Martin Park. I asked her if it was possible to wait until the morning of September 9th to reschedule in case the radar cleared up. I informed her I was looking at rescheduling for Sunday, September 13th, 2020. She then "penciled" me in for September 13th and allowed me to call back by 12:00pm the day of the original event to finalize the reschedule if need be. On September 9th, 2020, I called the city once again and finalized rescheduling my event for Sunday, September 13th.

A friend of mine, Molly Blahnik, had been in contact with the police around the same time I had been in contact with the city, to inform them of the event as we had no intentions of having any violent incidents or any trouble at all. We wanted the Sturgeon Bay Police Department to be well aware the event was being held with plenty of advanced notice.

On the morning of September 9th, 2020, I arrived at Martin Park in Sturgeon Bay at about 8:00am. My friend, Jennifer Quitko, who was co-hosting the event with me, met me at the park this time. Shortly after we arrived, her father and his girlfriend met us there to help set up a shelter tent for us above our table. Her father's name is Jeff Quitko and his girlfriend's name is Dawn Hughes. We set up a foldable, white table, a shelter tent, and a couple of chairs in the park at this time. The event was scheduled on social media to be held from 9:00am-4:00pm. On the front of the table, we hung three small signs that read, "Recall Petition, Sign Today." We placed two American flags and one Thin Blue Line American flag on the backside of our shelter tent and place four small signs near the road. Three of the signs read, "Help Save Wisconsin, Recall Evers," and the other one read, "Recall Evers, Sign Here."

There was a steady flow of citizens coming to sign the petition immediately beginning at 9:00am and this continued throughout the morning. There was no negativity or violence at any point through the morning. My personal friends, Manuel Rivas and Jorge Rivas arrived later in the morning and were also sitting there with us. Around 12:00pm, Molly Blahnik arrived and placed one more sign near the road that read, "RECALL EVERS, Sign here today!"

Around 1:15pm, I was sitting on the picnic table near out setup with Manuel, Jennifer, and Jorge eating a sandwich. Molly was standing behind the table and Jeff and Dawn were standing near Molly. A man approached us at the table and identified himself as a Sturgeon Bay City Alderman but did not provide his name. We identified this man as David Hayes in a later Google search of Sturgeon Bay Alderman. David was immediately confrontational with his words and asked me if I had a permit. I explained to him the same process that I went through to hold the event as listed in an earlier paragraph of this report. I made sure to let him know I paid the park rental fee, let the city know I would have a banner, and informed the police in advance to the event. I also informed him that a Sturgeon Bay Police Officer had been at the park briefly that morning already to talk to one of the people who was co-hosting the event with me. He became very nasty with his tone of voice and demanded I tell him who I spoke with at City Hall. I informed him I did not remember her name but I thought it started with an "S." He asked me if it was Stephanie, to which I replied, "I don't remember, but I don't think it was a Stephanie." He told me he had Stephanie's contact number but he did not want to call her on a Sunday. He went on to tell me that I needed to have physical permit on my person from the city and because I did not have one, I was not allowed to hold the event. He kept insisting I needed a permit and I told him, "I don't know what to tell you. I went through all the steps to do this with the city and they did not give me a permit. I am a citizen who pays taxes on this park and it is my Constitutional right to be here whether I contacted the city or not. You are welcome to call who you feel you need to. The police are well aware I am here and what I am doing. Call the police. "David replied, "I will do that! " and began to walk away angrily from the table while holding his phone up to his ear.

When he was about half-way from the location of the table to the end of the park where the stop sign is located, I turned to my friends and said, "Wow, what and asshole." I did not say this directly to David. David overheard me say this and began walking towards me in an aggressive manner. David then yelled, "What did you say, what did you say?" directing the question directly at me. I replied, "Nothing." Hayes then grew even more angry and got within my arms reach next to me, began pointing his finger in my face and angrily said, "Well, you're a bitch!" I replied, "I'm a bitch? Well, then you're an asshole." David then replied, "You want me to grab your pussy?" Directly after David said this to me, Manuel stood up so as to get in between David and I because David was acting very aggressively with his words. As soon as Manuel stood up, David turned in the other direction holding his phone up to his ear. He was in front of the table again when he said, "That is what Trump says!"

There were no political party affiliated signs or flags of any sort at this event. The only indication of any presidential support was the t-shirt that I was personally wearing. It was a dark blue t-shirt that read Trump 2020. I am assuming that David saw my shirt and this is what triggered him to make that sexually suggestive, harassing comment towards me. My friends that were standing with me all began shouting things like, "Wow, aren't you a public official?" towards him. We all stayed exactly where were and nobody followed him or even took steps towards him when that was said.

David then began walking around the park with his phone up to his ear looking at all of our signs near the road. After a couple minutes, he walked to the corner of the park near the stop sing and got in his car. David then sped through the Healthy Way parking lot in a diagonal direction to cut-through and drive very quickly up the road towards the Government Center across the street from the library. This was the only aggressive or negative incident we had all

WITNESS STATEMENTS:

JENNIFER QUITKO:

To Whom it may concern,
My name is Jennifer Quitko.

I was there yesterday when we had our Recall Evers Signing Event at Martin Park in Sturgeon Bay. The event began and remained peaceful until Alderman David Hayes of the 2nd district of the City of Sturgeon Bay aggressively approached us at about 1:15pm demanding we show him a permit for us being there. We informed him that City Hall has known about this event for weeks, knew what the event was for, who was hosting, and what signage would be displayed.

Amanda said we paid to rent the park with the city and filled out the form to rent the park so no other events occured that day. We both had reached out to police prior to the event as well, so they knew we were going to be there as well. Before he approached us, the police had checked on us a couple times throughout the morning.

He approached the table demanding us to tell him who is in charge, stating it was illegal for us be there, and that we needed to show him a physical permit that we supposedly should have had on our person, because he stated we had "political signs" out. He also asked for the name of the person who allowed us to hold the event at City Hall. The only signage at the event were a couple of signs near the road that read "Recall Evers, sign here." We also had two American flags and one thin blue line American flag. There were no political party signs promoted at this event.

Amanda told him that he is welcome to call the police and he angrily said, "Im going to!" And stomped around holding his phone while looking at our signs. Amanda turned to the 6 of us total there witnessing this happen (excluding Amanda) and under her breath said, "Wow, what an asshole."

He then turned around and aggressively charged at Amanda and yelled in her face saying, "You're a bitch! You want me to grab you by your pussy?"

Nobody replied to these statements. He immediately turned back around and starting stomping away while yelling, "Thats what Trump says!" Amanda was wearing a Trump 2020 tshirt, which is likely what provoked his anger.

At this time he was on the phone attempting to reach the police. He then got in his car and illegally sped through the Healthy Way's parking lot, diagonally

driving through the lot, and left. The police informed him we had every right to be there and were not breaking any laws. David Hayes is the Chairman of the Democratic Party of Door County.

JEFF QUITKO STATEMENT:

To whom it may concern,

Yesterday, September 13th 2020 my daughter Jennifer Quitko and Amanda Ducane we're hosting a recall Evers petition signing event in Martin Park in Sturgeon Bay. I had helped them set up a canopy that I was letting them use and we hung two American flags and an American Blue Line flag on the back of the canopy. I checked in on them periodically throughout the day to see if they needed any additional help. At around 1 p.m. I stopped back with some Subway sandwiches and additional tent Stakes for the canopy since it was windy that day. I was also accompanied by my girlfriend Dawn Hughes who was helping as well. Shortly after 1 p.m. a man approached and introduced himself as David Hayes and that he was the Sturgeon Bay alderman for that area. He started questioning the young women how about having a permit for being in the park and was told that they did have a permit and that the event was scheduled for the prior Wednesday but rescheduled for Sunday because of the rain on Wednesday. He asked why they did not have the permit on their person or displayed at the park. He was informed that they were not given a hard copy of the permit but in fact everything was legal and they had paid their fee for the permit. He became increasingly agitated and walked around looking at the signs that they had in the park. He was also told by Amanda that when filling out the permit she was asked if they would have signage in the park and she stated that they would. He then said that he was going to call the police and Amanda said that's fine go ahead. At this point he was walking away and Amanda had said under her breath "wow what an asshole". He heard that and then immediately started walking back to her and ask her "what did you just say?" She replied " nothing". In my opinion because she did not want to escalate the situation. He kept coming toward her and asked her again "what did you just say?" Finally she said "okay I said you are an asshole". Then as she was sitting at a picnic table he was right up to the picnic table 2 feet from her and said " well you are a bitch". She made no reply and then he immediately said " how would you like it if I grab you by your pussy " . Again no retaliatory remark was made. When he finally started walking away he said " well that's what Trump would have said " . Again nobody said anything after that, we were just all so surprised that he would say something like that and in front of so many people. As he was leaving he was on his phone, I assume with the police and left the park and sped off in his car.

DAWN HUGHES STATEMENT:

September 14, 2020

To Whom it May Concern:

At approximately 1:00 PM on Sunday, September 13th, 2020, I was in Martin Park, 207 S 3rd Ave, Sturgeon Bay, WI. Jennifer Quitko and Amanda DuCane were there at a table set up to collect signatures for a recall petition of Governor Tony Evers and Lieutenant Governor Mandela Barnes. A gentleman walked up to the table and announced he was David Hayes, alderman for that district, and that he had received a complaint from one of the residents in his district. He advised

Amanda and Jennifer that they were not allowed in the park to be conducting this type of business and asked to see their permit to be in the park. Amanda advised that the city did not provide her with a physical permit however were given permission to be there, and the park fee had been paid to use the park for the day to host the recall signing. She also advised that the city was well aware of their activity as they had to reschedule the date due to inclement weather conditions on. David continued to badger and harass Jennifer and Amanda about not having a permit and insisted that they are not allowed to be in the park and that they needed to leave. Amanda again repeated that they have permission to be there and were not going to leave. He became very upset and advised he was going to call the police. Amanda advised him to go ahead and call the police as they had permission to be there. As he walked away, Amanda looked at the small group of people visiting her, including myself, and said "wow, what an asshole". David heard her comment, turned around, walked back towards her, and angrily asked "What did you say?". Amanda politely replied "Nothing". He asked her if she called him an asshole, and she replied "yes, yes I did". By this time, he is directly in front of her as she was sitting at the picnic table. He then proceeded to raise his voice even more and said to her "Well you're a bitch, yeah, how would you like it if I grabbed you by your pussy?". At this point I felt threatened by his behavior and I turned around to I could hear him walk away saying "Well, look in the opposite direction. that's what Trump would have said". When I glanced over to see how far away he had walked away, I could see him on his phone, pacing around the auction items near the street where he was parked. He then he got into his vehicle and left. Within minutes an officer came to gather information from Amanda about the incident.

JORGE RIVAS WITNESS STATEMENT:

On the Sunday of 9/13/2020 Amanda DuQuaine invited my brother (Manuel Rivas) and I to take part in her event for the collection of signatures to recall governor Evers at Martin Park.

I had no part in assisting in the set up or filling for proper paperwork for renting the space as Amanda had already undergone that process. The police had already been notified about the event prior to us being there.

The event was going as planned with people steadily coming and going without any issues. At about 12pm there was 7 of us (Amanda, Jennifer, Molly, Jennifer's Father and his girlfriend, Manuel and I) around the tent. At around 1pm a man approached us and made clear that he was the city Alderman (in a tone suggesting he was the only Alderman) Immediately he went on to demand to see a permit from us. Amanda took the lead from there and explained to him the process she went through to rent out the space and the money she spent to make it official. The Alderman demanded in a rather confrontational tone that a physical permit must be shown to him. Amanda explained to him that no such permit was given to her but she had already filed the application, paid the fee and the police were well aware of this. The Alderman seemed bothered by Amanda's assertiveness and confidence in her explanation of her actions to secure the

spot for the event. He became more agitated and Amanda's patience began to narrow as she found herself having to repeat herself to the stubborn man. Eventually Amanda suggested he call the police if he really felt we were at wrong, clearly left frustrated and without any way to make him understand. The Alderman angrily said he would do just that and walked a few feet away from the tent while dialing on his phone.

Amanda looked at us in disbelief and said, "what an asshole." The man overheard and marched towards her in an aggressive manner clearly ignoring "social distancing" rules being within about 3 feet of her face. He pointed at her and called her a bitch. We were all obviously in shock to see such grotesque behavior coming from someone in his position. Like anyone in her situation, Amanda was not happy and responded by again calling him an asshole. The Alderman was at this point far from being professional and completely lost his cool. He leaned toward Amanda and loudly said," You want me to grab your pussy too?" All while gesturing with his hand the sexually explicit action. At this point Manuel went into Amanda's defense and yelled at him, "Hey that's enough!" As he stood up from his seat and moved towards Amanda. Immediately the Alderman backed away noticing we were not going to be quiet anymore after what he had just said. Instead of chosing his words wisely he proceeded to say, " what? That's what Trump says." From there the Alderman, we later identified as David Hayes, began walking towards his car seemingly trying to reach the police on his cellphone. Hayes then entered his car and drove off.

WITNESS STATEMENT MANUEL RIVAS:

On Sunday September 13, at around 1:00 p.m. at Martin Park of Sturgeon Bay we were approached by Mr. Hayes. Amanda Duquaine, Jennifer, Jennifer's parents, another female I don't know her name, my brother and I were in attendance; Amanda and Jennifer being the main organizers. Mr. Hayes asked the organizers several questions, such as if they had a permit to be there which quickly became more of an interrogation by him, quickly after, telling them that it was illegal for them to be there. Amanda explained the situation, that she wasn't issued a physical permit but had already paid for the spot and even had to reschedule. That she had spoken to a woman from his office but couldn't recall the exact name, he refused to give more details on that and to check with her. He wasn't accepting that as he became more visibly agitated, threatening to call the police. As he was walking away Amanda said, "wow what an asshole" not directly to him, but loud enough that he heard and it upset him quite a bit as he quickly turned around, got very near Amanda in a very aggressive way, pointing to her and called her a "bitch" and also asked, "if she wanted him to grab her pussy too." I was sitting right next to where he was standing when he got like that, I had to stand up and get in the way because his demanor was very aggressive that I thought for a moment he might actually assault her. He then walked off again and his reasoning for what he said was, "well Trump says that." He was on the phone with the police after he walked away in some distance and then got into his vehicle and drove off. There were no further problems later on in the day.

On September 17, 2020 at approximately 0730 hours I, Officer Snover, made phone contact with David Hayes, to receive his statement. Hayes explained he would come by the police department later in the morning today around 1100 hours with a typed up statement.

Hayes provided me with the following written statement:

Written Statement from David Hayes

On September 13 I was called by a constituent in District 2 of Sturgeon Bay, Wisconsin at approximately 1:56pm. Her concern was a group of people who set up a tent and several small flags at Martin Park. The caller said she thought they were soliciting signatures for a recall petition of Governor Evers.

I drove to the park and parked on Third Avenue near the corner of Oregon and 3rd. I approached the group and asked how they were doing they responded good. I introduced myself "I am the City Alderman for this District and am asking about a permit to have a tent up on city property". By now I was within 20 feet of the first person. The group looked at one individual who was sitting on the backside of a picnic table eating something. There was a man sitting at the table between the woman and myself (I was still standing about six feet from the man and about 10 feet from the woman (Amanda). None of the folks had masks on and they were all within 6 feet of one another- I never was closer than six feet from any of them because I had a mask on and did not want to get close.

I repeated my initial question-"Does anyone have a permit for this event". The woman (Amanda) said she did not have a permit and asked what I was talking about. I told her that "When someone conducts an event on city property that they are required to pay a fee and get a permit from the city and that on the permit it states that the applicant should have the permit with them during the event." Amanda again said she did not know what I was talking about and that she was never given a permit but had permission to be at the park. She also stated that she was originally scheduled to be at the Martin Park the previous Sunday but was rained out and rescheduled to the 13th. I asked her "Who did you speak with at City Hall" she responded she could not remember her name but said she thought her name started with a "S". I then said "Stephanie?" her response was no. I then said "Lori?" her response was no. She then said that the police had already spoken with her today (Sep 13) and given them permission to be there. I

said "The police do not grant permission for anyone to hold an event on city property. That would come from the Parks Department." By know I was beginning to think she did not have a permit or had even talked to anyone at City Hall about it- I am basing this on the fact she could not remember the staff persons name and did not have a permit or acted like she didn't even know about a permit. She then said I should call the police and talk to them. I said "That is what I plan to do. " I started to walk away while looking at my cellphone for the nonemergency Police Depart phone number. I was about 20 feet away when I heard her say Asshole. I turned around, took about two steps toward her (remember she was sitting at the far end of the picnic table with a man between us also sitting at the table) and asked her "What did you say? "She said I don't remember. I said "well I do, you called me an asshole". At which time the other folks both men and women said free speech, free speech. I stopped and said "Well I have free speech and I can call you an asshole too." "I can also call you a bitch." I turned around again and proceeded to continue walking away when I stopped (about 20 feet away again and said "Freedom of Speech just like Donald Trump, I can say "Can I grab your pussy?" At this time the other folks got more agitated and said that is too far, come on. I looked at the group and said "If donald trump can say that and get away with it I can too- Freedom of Speech". I then walked away from the group because I had found the phone number for the police department and was being connected to them.

I then spoke with the police department and explained who I was, where I was and what I was talking about— "a group was at Martin Park and did not show me a permit when I asked for it". I asked the officer to come over and talk to the group. I also asked the officer to give me a call after she had spoken with the group. I then back to what I was doing before I was called by the constituent.

Hayes was made aware that his conduct was inappropriate and caused a disturbance on September 13, 2020 at Martin Park. The citation was explained to Hayes and I told Hayes if he wished to contest the citation he should appear for the court date on October 19, 2020 at 0900 hours.
